#### **Breaking News: State of Illinois Programs for Small Business**

Gov. Pritzker today announced three new programs to help businesses impacted by the coronavirus pandemic. More details <u>here</u> but in brief:

- Hospitality Emergency Grant: Bars, restaurants and hotels with a valid license can receive grants
  up to \$50,000 to support working capital costs like payroll and rent. Applications being
  accepted now. Click here for more information.
- Illinois Small Business Emergency Loan Fund: low-interest, five-year loans of up to \$50,000 for small businesses (less than 50 employees) outside of City of Chicago. Deferred payments for first six months. Applications accepted starting April 1.
- Downstate Small Business Stabilization Program: Grants up to \$25,000 for businesses with less than 50 employees outside of the Chicago metropolitan area. Funds applied for by units of government (counties, cities, villages) on behalf of their businesses. (We will do more research into this program in particular.) Application materials available March 27.

## **Update from Bradley SBDC on SBA Emergency Loans**

Jim Foley of Bradley's Turner Center for Entrepreneurship reports that they have already helped over 50 businesses better understand the SBA Economic Injury Disaster Loan program. SBA has decided that all loan payments for the first 11 months will be deferred with only interest accruing. Businesses are reporting problems filing on the SBA portal during working hours and are encouraged to do so after hours. More information from Bradley here.

### US Department of Labor Guidance on Emergency Sick Leave and Expanded FMLA

The US Department of Labor today made available a set of resources regarding two important provisions of the Families First Act: the emergency sick leave provision and the expansion of the Family and Medical Leave Act. Both pieces of legislation impact businesses with 500 or fewer employees.
