* Job growth and/or has demonstrated resilience = Christian Brothers Auto - HR has gone up and beyond to stay open and be a front line service provider during the pandemic. They have juggled a large load of automotive services in order to expand their staff and keep their customers on the road.

* Provides exemplary customer service = CBA - HR has always been a top notch service provider, but during awkward times due to COVID-19, they have gone to great length to pick-up and deliver back customer vehicles in order to keep them safe and to innovate to meet the needs of their customers. CBA strives for each customer to be satisfied and has a motto "A nice difference", as they daily try to gain trust and change the stereotypes of other dishonest mechanics.

* Encourages and provides professional development of staff = CBA - HR has a true heart for their employees and provides a stable and fun environment to be lead in a way that advances their personal and professional development. The owner, Greg Joseph, is passionate about giving his employees room to grow and has a understanding heart that motivates his staff to excellence.

* Reinvests in the community (volunteering, donations, etc.) = CBA - HR has been a great philanthropic model in our community giving to over 10 non-profits on a consistent basis. 10% of gross sales goes back to assist local non-profits serving Douglas County . They normally (in non-COVID times) host two annual single parent service day, where staff volunteers their time and donated auto parts to fix safety issues on low-income family vehicles, at no charge. They regularly take vehicles to fix and donate used cars back to low-income families.
