

## HELEN STAFFORD SCHOLARSHIP CRITERIA

Helen, affectionately knows as "Selling Helen" in the real estate business during the 60's and 70's was about living and learning. The Helen Stafford Scholarship encourages REALTORS® to grow in their knowledge by gaining a Designation or Certification and shall be used by the recipient for any real estate related education for Designations or Certifications including ABR, CCIM, CR's, GRI and more. In addition, to be eligible for the Helen Stafford Scholarship, an individual must:
Be an active member of CCAR no longer than five years and have served on (and attended the required 75% of meetings) at least one CCAR Committee or Involvement Group for a minimum of one year.
Not have received the benefit of this scholarship within the last 24 months.
☐ Be a permanent resident of Illinois within Champaign County and surrounding areas.
Have completed a real estate related educational event with the past 12 months.
The maximum possible award is \$250.00. An individual who receives a Helen Stafford Scholarship may also apply for CCAR Scholarships.

## **The Application Process**
