Committees

Apprenticeship

My report for this issue is generally a summary of the 2017/2018 year to-date. The electrical trade has undergone some extreme adjustments. As the industry adjusts to the new lower volumes of work, the workforce has changed and become smaller as well. Training institutions have also had to adjust to the new lower number of apprentices. This has impacted seat availability. Where we were seeing long waiting lists in past years, there are now openings available and almost no students waiting. Any students on waiting lists are being absorbed and taken in. We are still seeing apprentices going back to back for their training sessions if they find themselves out of work; however, some of those that are working are deferring their technical training, especially those that are in their 4th year. Generally all the Training institutions are reducing staff and numbers of classes to adjust to the lower numbers. These adjustments in the apprenticeship labor force can be seen in the following statistical information.



The following are some of the current apprenticeship statistics as they relate to the entire province and its different regions. Currently there are about a total of 50,000 apprentices registered in all of Alberta for all trades. Although this number appears fairly large, it has been dropping steadily since the peak in 2014, when the total number of apprentices reach about 70,000. New apprentices entering the trade in 2014 reached about 24,000 while this year that number is almost half of that, down to about 12,500. As we look at the Electrical trade, which has also undergone a substantial reduction, the view is not as bleak. In the peak of 2014 there were about 13,000 Electrical apprentices, now down by 25% to about 10,500 apprentices. The correction from last year is about 12% down from about 11,700. New apprentices entering the Electrical trade this year, is down by 6% from last year, but also down by 50% from the peak of 2014. At this point it is hard to say if these numbers will continue to drop or will start to level off. What I can say is that we are now back at the same level we were in 2012, which was around 10,000. This was a more normal year-to-year average. Just as a comparison, the Plumbing trade also shows similar declining percentages of around 12% year over year. However, the Electrical trade still remains very healthy and still has the highest number of apprentices, at least twice as many over any of the next highest trades being Welding, Plumbing, or Heavy Equipment Technician. The real concern is if the New Apprentice number keeps dropping, it will once again leave a shortage at some point in time as the economy starts to show signs of recovery.

Some of the numbers that make up the Electrical trade apprentices are, 630 RAP students, 400 Indigenous, and almost 600 women. There are about 3000 4th years, 2500 3rd years, 2300 2nd years, and 2200 1st years. The numbers for the general regions across Alberta are approximately as follows, 1000 in Northern Alberta area, 4900 in the Edmonton area, 600, in the Red Deer Central area, 3400 in the Calgary area, and 600 in the Southern Alberta, Medicine Hat, and Lethbridge areas. There were about 1600 Journeyman Certificates issued for 2017, 1300 Red Seal Certificates, and about 48 Qualification certificates. There continues to be some complacency around writing and/or passing the Red Seal exam. Pass rates range from around 65% to 75%, and vary slightly from region to region.

Here are a few notes regarding some of the Training Institutions across Alberta. NAIT is trying to introduce and offer more practical training through the pre-employment courses; however Keyano College is looking at cancelling their pre-employment course due to low turnout. Other colleges are having good success with their pre-employment courses. Lakeland College is running a Red Seal prep course with good success. This year the training institutes will be busy getting ready to incorporate the new CEC material into the curriculum. The new curriculum will be ready for September of 2019. This will impact some students again, who will be working within two different code cycles.

Tuition fees will remain the same holding at about \$784 for an eight week training period. AIT will no longer be processing or creating the ILM's (Individual Learning Modules) as this will be left up to the Training Institutions (TI) to create. Currently the TI's are collaborating to produce this material in a unified effort to be ready for the September 2019 term.

Here are some comments from AIT/Client services: A reminder to employers of the process in hiring an apprentice. The Trades Secrets website has a form that outlines the five steps to hiring an apprentice. Also, reminding all employers about the ongoing enforcement and random site inspections to ensure workers are certified if working within the Trade Scope. Currently two enforcement officers are operating in each of the areas of Calgary, Edmonton, and Fort McMurray. Also, reminding us of the available complaint line for reporting infractions of the current certification rules. This is done online through the Trade Secrets website, found under the tab "About Us" and then tab "Submit a Compliance Complaint". Soon there will also be an electronic employer portal for employers to enter and update apprenticeship information. This will be in conjunction with an electronic Blue Book section. However, the exact release date of this function is still TBD.

Here are a few general comments on current and upcoming information. The Electrical trade has a new AIT Manager, Brent Melnyk, who is replacing Ward Mewhort. This year we will see a change in the PAC Presiding Officer position as Darcy Tangedal has completed his term. A replacement will be named in the coming months after final voting. Also, locally for Edmonton, the Electrical trade has a new client services Rep, Chad Hoflin and although new to us he has been in place for a few months now.

Regarding harmonization, the Red Seal Alignment process has been completed for the Alberta Construction Electrician, however not for an Industrial Electrician. Another positive achievement is The Provincial Territorial Apprentice Mobility Protocol, which is an agreement between provinces to help apprentices move across the country and still have their credentials recognized, so they can continue their trade and technical training uninterrupted. This applies to apprentices whether moving temporarily or permanently.

Hopefully this coming year will bring more economic recovery, resulting in stability for all our industry stakeholders.

The last Electrical Sub Council meeting was held in Edmonton on May 7, 2018. The matters for discussion included the following.



- Discussions relative to the draft Terms of Reference for the new “Hazardous Locations Working Group” (replacing the Oil and Gas working group) including the matrix and representation. Suggested representation is up to 2 industry representatives from each of the 5 industry segments, plus the required Electrical Sub Council member as Chair.
- Discussions relative to providing a path for SCO’s to submit building code items to the Electrical Sub Council building code liaison to be forwarded to the Building Sub Council.
- Discussions continued about Concrete Encasements and the consideration of drafting a Standata for an interim solution to proposed changes to CE Code Part 1.

- Discussions continued regarding a review of processes throughout the province for Street Lighting and Traffic Control Infrastructure.
- Discussions regarding the consideration to include all pictograms of certification marks and special inspection labels that are acceptable for use in Alberta, updated annually, including the applicable Standards Council of Canada links.
- Discussions continued about Power over Ethernet considerations and recommendations.
- Discussions relative to Wellhead Process Sealing and the Section 18 Standata.
- Discussions relative to Meter Mounted Devices and their installation requirements such as permits, device approvals, and qualifications to perform the installations.
- Update discussions on the issue of identifying demarcation between CE Code Part 1 and Utility installations.

The Safety Codes Council has now moved to their new location and all meeting go forward will be held at the new location. **Suite 500, 10405 Jasper Avenue.**

JOE'S CODES

In this edition I wanted to discuss the recently released Standata 14-BCI-002R1 for Visual signals. Paul Chang and I worked with a small group to develop and release this Standata to offer additional clarity regarding strobes and visual signals connected to a fire alarm system. The wording and intent aligns closely

- 1) Where a fire alarm system is installed, visual signals shall be provided in addition to alarm signals.
 - a) in buildings or portions thereof intended for use primarily by persons with a hearing impairment,
 - b) in assembly occupancies in which music and other sounds associated with performances could exceed 100dBA,
 - c) in any floor area in which the ambient noise level is more than 87 dBA, and
 - d) in any floor area in which the occupants
 - i) use ear protection devices,
 - ii) are located in an audiometric booth, or
 - iii) sound-insulating enclosures
 - e) in public corridors serving a Group B, C, D, or E major occupancy
 - f) in corridors used by the public serving a Group A major occupancy,
 - g) in washrooms, except
 - i) those located within suites of residential occupancy,
 - ii) those located within suites of care occupancy,
 - iii) those located within patients' sleeping rooms, or
 - iv) single toilet rooms
 - h) in universal toilet rooms (in accordance with Article 3.8.3.12, and

with the National Building Code of Canada and what we will be harmonizing with in 2020. Please check your email for the Standata that was sent out by the ECAA office on May 30th for link to the full document.

- i) in a suite of residential occupancy; such that at least one device is located within the principal living area
- 2) Visual signal devices required by Sentence (1) shall be installed so that the signal from at least one device is visible throughout the floor area or portion thereof in which they are installed.
- 3) The visual signal required by (i) shall be visible within the residential suite's principal living area (i.e. living room); which is intended for use by all occupants of the suite.
- 4) Installations shall conform to CAN/ULC-S523-06 "Installation of Fire Alarm Systems" including amendment 1 issued February 2011.

This INTERPRETATION is applicable throughout the province of Alberta.

Suncor Random Alcohol and Drug Testing.

The Suncor Energy Random Drug Testing Policy grieved by UNIFOR Local 707A is the high profile Alcohol & Drug case for Alberta industry in the management of workplace safety. To understand this issue we have put together the following events:

June 20, 2012, Suncor announced to its employees that it would be introducing a new drug and alcohol policy on October 15, 2012 which would include random drug and alcohol testing in safety sensitive positions.

In response to this announcement, the Union filed a grievance.

A three member arbitration panel heard the 2012 UNIFO grievance in 2013. The arbitration award was released on March 18, 2014. The majority decision allowed the grievance whereas one arbitrator dissented and would have dismissed it.

Suncor applied for Judicial Review in the Court of Queen's Bench of this award. In a decision dated May 18, 2016 B.D. Nixon J granted the application for Judicial Review and remitted the matter back to arbitration before a fresh panel.

UNIFOR filed an application seeking leave to appeal this decision to the Supreme Court of Canada.



On June 14, 2018, the Supreme Court of Canada decided it will not hear a union's appeal of a key ruling about random drug testing at Suncor Energy's oilsands operations in northeast Alberta. The matter is to be returned to a fresh arbitration panel.

Training Programs At The Electrical Training Center. There are twenty five plus training programs offered at the Electrical Industry Training Center. They have been developed over the past thirty-five years and provide training specific to the work performed by our contractors. When contractors require new employees with any of the training programs, the contractor can specify that anyone wishing to take a referral for employment must have the required training. When the person reports to the contractor requesting to be employed, the contractor can then interview the person and require a copy of the training certificate before deciding whether to accept the person for employment.
