- b. Finance: The April MRPA Account Statement value is \$980,501.40, an increase of \$24,925 over the March Statement. The compound rate of growth is averaging 6.6% year to date, which is a good return on our investment.

  - HB 321 Adult Changing Facilities this bill passed and will require changing facilities in certain public buildings built or significantly altered after October 1, 2022.
  - ii. <u>HB 581 Labor and Employment Standards During an Emergency</u> it is unknown how this bill may directly or indirectly impact Recreation & Parks in the future.
