# They Said What?

Your government relations team is downtown almost daily when the Legislature is

in town. We are talking with legislators, listening to floor speeches, and listening in committee meetings. Maybe you remember the show, "Kids Say the Darndest Things." Well, if the legislative process was a television show, it might be called, "Legislators Say the Darndest Things."

I started working downtown in 1985, so I have heard a lot. But lately it feels like builders, developers and housing in general have been generating some quotable moments from legislators. I always tell legislators that housing should not be a political issue, so I am not going to identify the legislator, or what party they belong to.

- 1. A legislator had these remarks as their no vote explanation. "I have major concerns with these bills. I understand that there is good intention behind them, but like much of our good intention there is a lot of opportunity for abuse and one of my major concerns in this process is that a developer, for example, or a landlord would use this money to improve their residence, to improve their property, and then turn around and raise rent rates making it yet more difficult for low-income individuals to find housing. This time, they'd be doing it with the taxpayers' help. I am a "no" vote and I encourage a "no" vote on these bills."
- 2. On another package of bills, this comment was made. "If legislators are going to subsidize developers, the subsidy should be part of the budget. If not, they should be subject to limits. This bill keeps subsidies to select developers out of the budget and increases the limit amounts. The Legislature should keep control of state fiscal policy, and this bill defers too much control over spending to administrators. I encourage my colleagues to be more skeptical of the effectiveness of developer subsidies. Recipients are going to collect large checks from taxpayers and they ought to be held to a high standard of success, for what is ostensibly labeled a transformational development should be required

- to live up to the label. If we are saying that special treatment is necessary to transform these local cities then we should require improvement in the city's economic performance."
- 3. The third example is from a recent meet and greet with a freshman legislator. "I am not a NIMBY. We need more housing."

The Friends of Housing Political Action Committee is YOUR voice in the political process. Between January 1 and April 20 of this year, union groups spent at least \$657,900.00 on contributions to state lawmakers' and Governor Whitmer's campaign accounts, and associated PACs, according to a Bridge Michigan analysis of the latest campaign finance reports filed April 25.

What did your Friends of Housing Political Action Committee file on April 25th? Our contributions for the same time frame totaled \$3,475.00. Our cash on hand at the time of that filing, \$14,537.57. The 2024 election cycle began on November 9, 2022 - you read that right. If every member made a personal voluntary donation in the amount of \$100.00, we would reach our goal of \$125,000.00 in no time. In fact, if that was to happen, we would have \$437,000.00 — more than our goal for this year. That is counting every builder, associate and affiliate member.

# What Does Your State Association Actually Do?

We know many Michigan Builder readers may not be fully aware of what the HBA of Michigan (HBAM) does. They might use the state association's Meijer discount program or some other benefit created by HBAM, but may never realize or understand the dayto-day work undertaken by HBAM's team in Lansing.

Most of HBAM's work has to do with advocating for our industry—in the legislature, in the courts, within the halls of state government...but it also advocates for individual members when they need help. Many members don't always realize that they can reach out to their state association in the event that they have a permitting, legal, regulatory, utility connection or some other issue they're dealing with. Our team in Lansing can often help or, at a minimum, offer good advice and point you in the right direction.

#### On the Regulatory Front—

We are seeing more and more development activities get flagged for environmental/wetland permit reviews by the State. We are one of the few states that has delegated authority from the federal government to handle this permitting activity. We are part of a broader business coalition working with the State to try and identify ways to speed reviews and eliminate those that aren't required by law. If you are or have experienced any recent permitting challenges like this, please let Dawn Crandall or our CEO, Bob Filka, know about it.

We are nearing the finish line in our permit fee overcharge lawsuit against the City of Troy. The final two remaining issues in our lawsuit were heard in early December and a lower Michigan court did hand down a ruling in February. That ruling upheld our position that communities can only charge what it costs them to run their building departments and can't include all sorts of overhead expenses. In short, if they are already paying a city manager or a fire chief, etc., they can't tack on a portion of that person's time as an additional cost. The court also ruled that the city violated the Headlee Amendment to the State's Constitution (the purpose of which is to prevent cities from passing along tax increases under the guise of

fees). Those are very positive results from our lawsuit. However, in that same ruling, the judge erroneously ruled that HBAM did not have standing to be awarded its legal fees in this case.

Awarding legal fees to those who bring suit and prevail against cities who violate Headlee are supposed to be part of the consequences of breaking this state law. As such, we filed an appeal last month and ultimately expect to get our legal fees back. This could take another 12 to 18 months of legal wrangling to collect. When we do get our legal fees back, our strength to fight on other fronts will be greatly enhanced, as we are owed more than \$500,000.

We are Fighting Against Local "Zoning" Proposals Used to Push Code Changes. We are working hard to try and nip at least two local government efforts to use a zoning ordinance process to require things that are really code issues. We have recently had our legal counsel send a letter to both Ann Arbor and the City of Kentwood, informing them that our state has a uniform set of codes and they can't change those code requirements locally under the guise of it being a "zoning" issue. In Ann Arbor, it's about electrification and a proposed ordinance to ban natural gas in homes and commercial buildings. In Kentwood, it's about window and building material requirements. Our efforts have altered or at least slowed down these two cases. Your state association regularly works to reign in overreaching actions by local government. Many times we do so without others around the state knowing about such efforts.

#### On the Legislative Front—


Governor Whitmer signed four of our bills into law right before Christmas. All four bills will provide local communities new or expanded financial tools to attract/support workforce housing investment. This package of bills was promoted not only by HBAM, but a diverse and bi-partisan coalition of groups and legislators. One such group is a local one in your region, Housing North. They and other business groups are key members of this coalition. Dawn Crandall, on our HBAM team, has been the point person working with

our coalition partners and another set of coalition bills will be working their way through the legislature later this year. Earlier this year, Governor Whitmer also appointed our CEO, Bob Filka, as one of 18 members of Michigan's Housing Advisory Board. This board will, among other things, be working with MSHDA and other state agencies on program and policy improvements to speed the construction of more workforce housing across the state.

#### On the Building Code Front—

No New Codes in Place for at least another year: Our team in Lansing has met with the State's Bureau of Construction Codes Director a half dozen times already this year and he has now indicated that it will be next summer, at the earliest, before we have any new residential code rules in place and in force. By law, the State was supposed to have updated our residential code in 2021. They're two years behind. The big fight, which has already begun, is over the State's push to implement new energy efficiency requirements.

A number of years ago, our state association helped usher in a law that requires all energy efficiency changes to the code to have a 7-year payback or better. That very law just recently helped us delay the State's push for new energy code requirements. The state had moved forward with the adoption of the 2021 IECC without amendments back in March. These proposed rules would add several thousand dollars in costs for the construction of new housing. We know that several of the provisions in this model code would not meet the 7-year payback requirement in our state law. So, when the state's proposed rules on this reached the legislature's Joint Committee on Administrative Rules, your state association went to work-educating members of that committee about the state's failure to address the 7-year payback requirement. Last month, after all this questioning, the State withdrew their proposed energy code changes, citing the need to address several shortfalls and to take more public input. They didn't cite our education efforts, but we know what caused them to pull back-your HBA voice in Lansing.

# New Tools In Your Toolbox

The Housing Michigan Coalition saw success last year with four bills signed into law by Governor Whitmer. Three of those bills were given immediate effect, which means as soon as the ink was dry on the bills, they were available for use. You can find out more on those laws on our website.

The fourth bill, Senator Moss's legislation to expand Neighborhood Enterprise Zones (NEZ) to all communities, went into effect on June 1, 2023. This law is a tool to use for community infill projects. The key to this is that infrastructure needs to already be in place.

Public Act 238 of 2022 will allow all cities, villages, and townships to use NEZs. The newly eligible local units may designate a NEZ only if the project encourages compact development (minimum of five dwelling units per acre), is adjacent to existing development and can utilize existing infrastructure. The NEZ tax only applies while the dwelling is occupied by a household at < 120% area median income (AMI). Income must be reported annually to the local assessor for determination.

Additional information on this new tool can also be found on our website.

We are expecting an expansion of the tax increment financing tool will be available by the end of summer. Senator Sam Singh (D-East Lansing) was lead on a package of bills which expands Brownfield Tax Increment Financing (TIF) to allow for support for workforce housing for those earning up to 120% of the area median income (AMI).

The legislation specifically:

Allows for the use of housing development activities including:

- Construction
- Rehabilitation
- Site preparation
- Acquisition costs for blighted or obsolete rental units
- Public infrastructure and safety improvements necessary for a qualified project
- Filling financial gaps associated with the development of housing prices for qualified households

This is a 100% opt-in tool. Through public-private partnerships with housing providers, developers and builders; local leaders can take action to meet their community needs. There will be local control over if, when, how, and for what to use it. The goal is to support market-based forces to increase housing supply where it is needed most - attainable housing for working households. Research shows that there is a significant gap in housing at all price points, and we are struggling to provide options for households earning 60% to 120% of area median incomes. This effort creates solutions to address this need and will have impact across the housing spectrum.

These bills create tools for local governments to partner with non- and for-profit developers, builders and property owners to create or retain affordability and drive investment in housing that is attainable to more households across Michigan. The public and private partners will make decisions based on community goals and site-specific needs, project costs and economic viability of potential investments.

# **Numbers Matter: HBAs Across the State and Country** Provide Voice & Platform for **Your Industry**

Your local home builders association is one of 19 local associations across the state and one of more than 600 local associations across the country. At the national level, HBAs are some 120,000 members strong. In Michigan, with nearly 5,000 members. we're the largest construction-related association in the state.

We've had tremendous success over the years fending off government overreach and advocating for policies that result in more attainable housing in our state, including a recent victory delaying a new set of codes for our industry for at least another year (see "Codes" story in this issue). But to sustain our success in the future and to make sure we have adequate financial resources in the legal, political and workforce development arenas, your state association's leadership group has set ambitious fundraising goals. The plan our state board adopted has a goal of raising some \$450,000 over the next two years. This year, our goal is to raise:

\$50,000 for HBA of Michigan's Legal Action Fund

\$125,000 for our state Friends of Housing Political Action Committee

\$25,000 for our national NAHB **Build PAC** 

\$25,000 for Skilled to Build Michigan Foundation

board members have pledged to commit a minimum of \$125 annually to each of these pillars, or \$500 a year. Our senior officers have pledged \$250 to each pillar, or \$1,000 a year.

I know we all have many compelling tugs at our wallets. But if we truly want our industry to succeed and be viable for future generations, establishing a giving commitment like this is a necessity. If we don't, we will all pay later with higher costs and more burdensome regulations. With political winds ever changing, money matters more now than ever-at both the state and national level. In the legal arena, we see more and more fights we should be engaging in but don't have the resources to do so. In the workforce development area, we




# Michigan Needs Your Expertise


# **Cultivate, Educate** and Recruit

Skilled Build to Michigan Foundation received a \$2M grant from the state of Michigan last year, and this spring we were able to deliver the book, "Build Your Future, The Complete Guide to A Skilled Trades Career," to almost every 8-12th grader in the state of Michigan. We did have a couple of intermediate school districts who refused delivery.

In our first year, we had a little over 200 students in our program. While there were some bumps in the road. we learned from those bumps, and are continuing with our credential in the 2023/2024 school year.
