Purpose of the Fall Preview:

The SRVBCA Fall Preview of Homes is a scaled back version of the Parade of Homes, and the main purpose is to help our builders get their inventory homes in front of the public and find families for them before the winter.

We are adding a virtual only option. Your home will not be open to the public, but you want to get the virtual 3D tour in the Fall Preview.

Fall Preview of Homes Instruction and Information

- **DATES:** Saturday and Sunday, October 19th & 20th Saturday and Sunday, October 26th & 27th
- **TIMES:** Saturday: 12:00 P.M. 6:00 P.M. Sunday: 12:00 P.M. 5:00 P.M.
- FEES: For Members Only!!! \$1,500 per home plus a \$150 sign deposit *\$800 per home (virtual only) no sign deposit

2024 Fall Preview of Homes Magazine will be on the SRVBCA Website for a few years.

NOTE:

All participating builders must be an approved member of the SRVBCA. An application for membership must be received at the time the contracts are turned in. New builders will have 30 days for review of approval by the members and the board, to qualify to be in the Fall Preview of Homes. If an application is not approved, all monies received including membership dues, entry fee(s) and sign deposits will be returned.

Unless all information that is required from the builder is submitted with the entry fee, the builder will not be considered an entrant.

No Entries Accepted After Tuesday, Aug. 20th, 2023.

Completed contracts turned in, *must be accompanied by*:

- RCE Number provided by the Idaho Division of Occupational Licensing
- Floor Plan (does not need to be a new floorplan)
- Entry Fee
- Sign Deposit (\$200.00 which \$150 is refundable when flags and signs are returned in good condition)
- Map (include longitude & latitude) ~*the SRVBCA is not responsible for issues if map, longitude & latitude are not correct.* Please note new construction is not always right on.

REALTOR/DEVELOPER REQUIREMENT

It will be the <u>BUILDERS</u> responsibility to make sure his realtor and/or developer is a member of the Snake River Valley Building Contractors Association to show the home during the Fall Preview of Homes.

SIGNS

A \$200.00 fee will be required as a sign deposit and will be rendered in the form of a check. \$150 of the sign deposit will be refunded within two weeks upon the signs being returned and the builder has not violated the policy with the realtor/developer being a member of the SRVBCA. \$50 will be used to repair or purchase new signs. The full sign deposit will be forfeited unless all signs & flags are returned in a usable condition to the SRVBCA office, and the builder did not violate the above requirements.

REFUNDS

If any builder wishes to remove their entry from the Fall Preview of Homes after Thursday, August 29th, he/she will be required to purchase that space and use it for advertising.

FALL PREVIEW OF HOMES SHOWING REQUIREMENT

All homes must be trimmed and painted both inside and outside and try for approximately 90% completion of your home. We are asking that you keep in mind the safety of the public being the number one concern, the appearance of your home and that the job site being clean. The homes are required to be open for the entire duration of the Fall Preview of Homes and staffed during the times specified within this agreement. Any deviation from the showing requirement must be approved in writing by the committee. If the showing requirements are not met, you will forfeit your sign deposit.

CONTRACTORS REGISTRATION

Contractors Registration Number: The builder shall deliver proof to the SRVBCA office with entry fee and signed contract a copy of his/her RCE or RCT Number.

SALE OF HOUSE

If the house sells prior to the Fall Preview of Homes arrangements are to be made with the owner, regarding the showing of the house during the Fall Preview of Homes. It will be the responsibility of the builder and or representative to make arrangements with the owner. The home(s) cannot, at any time before or during the Fall Preview of Homes, be occupied.
