I’m very appreciative of the work that the Citizens for Big Lake Freedom Rock have done to honor our local men and women who gave their time, expertise and lives for us!*

Last September Big Lake became the fourth city in Minnesota to sponsor a Freedom Rock painted by internationally-known artist Bubba Sorenson. Bubba’s goal is to honor veterans in each state and he personalizes each one, using local veterans. Big Lake Freedom Rock is featured on [his webpage here!](#)

For more than ten years, Karen Blake and Linda Paulson have organized veteran-focused events at their local church in Big Lake. Karen has visited the majority of the Freedom Rocks in Iowa. “We did not have a blueprint to know how to proceed,” Karen remembered, “ but we just knew we wanted a Freedom Rock® in Big Lake.”

Linda added, “We knew we would need the approval, support and encouragement of all the veteran organizations in Big Lake and we hoped to inspire the business community as well.” The pair visited each organization and joined the Big Lake Chamber in 2019 and the American Legion Auxiliary #147, spreading the word about the project. The local newspapers also published updates on the project.

No government funding or large corporation donations covered the costs but the group was confident the funds would come. A quarry donated the 31-ton rock and the group started

selling \$100 Patriotic pavers to be placed around the rock. This gave people all over the U.S. a way to honor their veterans by dedicating a paver to them. They installed and dedicated more than 200 pavers at the dedication last year and plan to install another 100 in a couple months.

Linda noted, "This project has been totally faith-based and continues that way today." Karen added, "There have been many fascinating service stories shared and miracles happening when people gave their time, money, talent and use of equipment to make this project a reality. The project has been supported by hundreds of people in Big Lake and central MN. Our high school football team dug out the foundation area and volunteers got the area at Lakeside Park level."

"Phase II of Freedom Rock is to provide a shelter," continued Linda, "to protect the rock from the weather and provide an area for lighted and comfortable viewing and reflection. We're thankful to Structural Buildings, Bogart, Pederson and Connexus in helping us. We want to create a beautiful rest stop for tourists and home town folks to show all the veterans and their families that we appreciate them. The concept of 'Freedom' and the men and women who fought and died for it is something we want to **ever honor and never forget.**"

Watch for the Freedom Rock entry in Spud Fest parade next Saturday June 25 as they honor local **vet-eran** potato farmers and farm workers. They will continue selling pavers and asking for donations until the shelter is completed. They have names of area veterans who would like a paver but don't have the

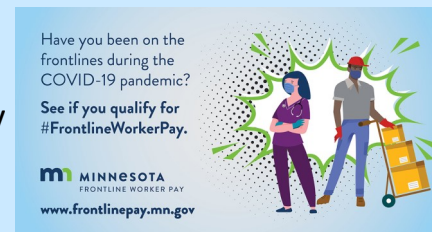

**Chamber Legislative Successes!** This past legislative session, the Big Lake Chamber of Commerce & Industry along with other Chambers and the Minnesota Chamber advocated for businesses by contacting state legislators, Governor Walz, and local elected officials on following bills that passed:

1. Unemployment Insurance (UI) Trust Fund Replenishment. Interest on the depleted fund from COVID expenditures was costing \$30,000/day. Employers had already received double and triple percent increases in the \$10,000-28,000 range for the first quarter of 2022. With the bill passed and signed, employers should check their UI account and use any credits they have.
2. Health Care Reinsurance to assist small business owners and individuals in keeping health care premiums at a reasonable level. Approved for 5 more years and funded for 3.
3. Growler Bill allowing breweries such as Lupulin Brewing Company to increase its growler sales and sell 4 and 6-packs. The Chamber supported Lupulin's amended ordinance at the June 8th City Council meeting. [Here is the link](#) on the bill.

**Frontline Worker Pay:** eligible workers have until July 22nd to apply if they worked at least 120 hours between March 15, 2020-June 30, 2021 in 19 industries. They could not have received more than 20 cumulative weeks of unemployment insurance. Nearly 400,000 applicants applied in the first week. All approved applicants will receive an equal payment this fall up to a maximum of \$1500. Please register and view this information at [www.frontlinepay.mn.gov](http://www.frontlinepay.mn.gov)



**Minnesota Chamber** presented the graph at right last month at their Statewide Policy Tour which compares MN to other states. While we remain 3rd highest in the nation on corporate income taxes and 5th highest on individual taxes, the work of Sherburne County EDA and City of Big Lake Economic Development Authority has helped MN in its 1st place ranking of businesses surviving 5 years. Unfortunately, our start-ups in MN rank one of the lowest at 48th in the nation.
