**Trade Practice & Tied-House/Unlawful Interstate & DtC Investigations**

Provide an overview of recent Trade Practice and Industry level investigations conducted by Massachusetts Investigators. These cases will cover straw distribution companies utilized to circumvent the Three-Tier System and unlawful inducements. Investigators will cover these cases from beginning to end; providing investigative advice and guidance based on their experiences through the investigative process.

An ALE agent must be well verse in ABC licensed establishments and those establishments that are selling alcoholic beverages illegally. Agents must know how to recognize these types of establishments and how to properly conduct an investigation dealing with an illegal outlet to ensure the successful prosecution of the case.

Illegal outlets pose a nuisance to the communities in which they are operated and are located all over North Carolina from big cities to small towns. They may be in a private residence, on a college campus, in clubs or businesses from one end of the state to the other. Agents will encounter all types of illegal outlets during their career including shot houses, clubs and illegal ownerships. This will require the agent to be prepared with the knowledge and investigative techniques to successfully build a case against those operating the illegal outlets.

### **North Carolina S.A.V.E Program - Stop Alcohol Violence through Education**

The goal of the S.A.V.E. Program is to ensure that licensees and their employees understand their role in preventing violence in and around their alcohol establishment. Agents review how to:

Recognize physical signs of violence

- Effectively address violent behavior when it occurs
- Prevent the escalation of violence through policy changes
- Deter future acts of violence at your place of work
- What to do if violence does occur
- Review areas of high liability for an alcohol establishment

### **From Streets to Peaks, Value of the Town and Gown Relationship**

Unfortunately, many times, the lifestyles of students clash with local residents who are awoken by late night noise, music, parties and disruptive conduct. Balancing public safety, police, fire & code and keeping students safe in today’s police climate while allowing students to be students will always be viewed by many as police being heavy handed. Managing good community policing tactics and working together with others may make your job less complicated.

### **Alcohol Outlet Density: Why it Matters and How to Track it**

Greater availability of alcohol is associated with a number of negative outcomes, including increased crime rates, traffic crashes, violence, and property damage. An overconcentration of outlets that sell alcohol, or a high alcohol outlet density, can further amplify these public health and safety issues. Research suggests that high alcohol outlet density also corresponds with higher levels of excessive drinking, including among youth.

Using GIS mapping is a powerful way to assess and monitor alcohol outlet locations. Mapping can also guide the development of enforcement strategies at the state or local level. This session will equip you with an understanding of how alcohol outlet density impacts the health and safety of your communities. You’ll also walk away with greater awareness of how this data can support licensing goals and offer a fuller picture of the impact of alcohol outlets on our communities.

**North Carolina Nuisance Abatement Team**

During this training class a foundational knowledge of Chapter 19, North Carolina Nuisance Abatement Laws, will be provided to other agencies. Each state has different laws and this class will provide a ground work to take back to your local politicians to discuss law changes and how it can assist your local agencies with violent properties and nuisance locations. You will have the resources and knowledge regarding nuisance laws and how these are utilized when traditional law enforcement tools to handle community problems have failed. We will discuss the penalties North Carolina law sets out including fines, forfeitures, perpetual restrictive covenants on property

(including the complete loss or use of the property) and jail time for failing to comply with judgments. These cases are brought on behalf of the State of North Carolina, the civil action targets property used for specified illegal purposes. As defined in statute, nuisance activities include prostitution, gambling, illegal possession or sale of drugs or alcoholic beverages, and repeated acts which create a breach of the peace. We will discuss NC Alcohol Law Enforcements involvement from the team's inception in 2016, they serve as the lead investigative agency for Nuisance Abatement actions. This team has accepted hundreds of requests from local law enforcement agencies to find permanent solutions to rid communities of nuisance properties, nightclubs, violent outlets, hotels and illegal bars.

### **Generational Effects of Alcohol in America**

The key to a successful outcome during any encounter is knowing who your audience is. Knowing what is important and how each generation views and reacts to situations will help anticipate problems, and will inevitably increase the potential for a more successful outcome for everyone involved.

### **Enforcement Capacity Resources: How does your state stack up?**

Through the National Alcohol Beverage Control Association's Awards Program, the Bureau of Alcoholic Beverages and Lottery Organization (BABLO) secured funding to conduct a compliance and resource capacity assessment in 2022. In recent years, alcohol licensing has increased, and alcohol enforcement responsibilities have been decentralized putting more demands on BABLO's regulatory resources. To better understand its internal capacity in comparison to other states, BABLO sought the expertise of an alcohol researcher to evaluate alcohol enforcement and regulatory capacity and resources across the United States. This assessment is the first systematic measurement of regulatory and enforcement capacity. It will provide valuable insights for all states looking to determine how their resources to provide effective customer service to licensees and adequate protections to the public compared to other states. Session attendees will review the assessment findings, discuss their implications and explore how to use the findings in their own state

### **Duty to Intervene-Law Enforcement Suicide**

Duty to intervene policies are being enacted nationwide to counter excessive force claims. Equally as important is a duty to intervene to counter officers experiencing a mental health crisis, i.e., stress and depression, which none of us are immune to, and suicide. The stigma attached to treatment for a mental health crisis in law enforcement must end. This workshop covers duty to intervene policies and profiles several real-life examples of officers in crisis who took the "easy" way out whereby a simple intervening gesture may have saved their life.

### **GIS Solutions for Alcohol Enforcement**

At the beginning of Fiscal Year 2020, the Alabama Law Enforcement Agency (ALEA) State Bureau of Investigation (SBI) successfully implemented a mobile GIS tool for alcohol and tobacco minor compliance enforcement operations. This innovative, easy to use, and convenient tool enables the agent in the field to be more efficient and effective during all phases of the compliance detail. The success of this tool led to the incorporation of GIS in other workflows such as investigating alcohol and tobacco related complaints, maintaining training and firearms records for certification of sworn personnel, and managing department resources. This presentation will discuss the details of each of these GIS solutions and how they positively impact the daily operations of alcohol law

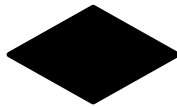

#### **“Street Stories- The Intersection of Human Trafficking, Alcohol and Drug Use and Abuse”**

Human trafficking hides in plain sight. This workshop will explore the intersection of drugs and alcohol with human trafficking. Alcohol and drugs are frequently used by traffickers to recruit and retain victims and many trafficking victims have alcohol and drug dependency issues as a result of the horrific trauma they survive. Using case studies from victims served in the YWCA’s PAATH15 trafficking shelter recovery program, presenters will illustrate the intersection of alcohol and drug use and abuse; the role that bars and restaurants play in the facilitation of trafficking; and the signs, symptoms and indicators for trafficking victims and perpetrators recruitment tactics. ## ***Speakers***

### **Stephen A. Zappala, Jr., Allegheny County District Attorney**



Stephen A. Zappala Jr. has served as District Attorney of Allegheny County since 1998, overseeing more than 300,000 indictments during his tenure. Mr. Zappala has used his time as District Attorney to effectuate significant changes in the operation of the office including the creation of dedicated prosecution units focusing on such crimes as child abuse, domestic violence, auto theft, insurance fraud, and a dedicated unit to help the victims of elder abuse. DA Zappala directed the creation of “specialty courts” such as Drug Court, Veteran’s Court, DUI Court and Mental Health

Court, all of which shift the focus to treatment and rehabilitation of the offenders.

As the chief law enforcement officer in Allegheny County, Mr. Zappala is heavily involved in the community and has served as a board member for such organizations as Animal Friends, the Center for Victims of Violence and Crime, and the Catholic Youth Association.

Mr. Zappala has also served as a member of the National Review Board of the United States Conference of Catholic Bishops; the Executive Advisory Board for Special Olympics Pennsylvania; the Advisory Council to the Pennsylvania Supreme Court’s Office of Elder Justice in the Courts; Joint Legislative Commission on Conviction Integrity; Joint Legislative Commission on Capital Punishment; New York University School of Law’s Law Enforcement Leaders to Reduce Crime and Incarceration and the Pennsylvania District Attorney’s Executive Board. Mr. Zappala is recognized as an honorary lifetime member of the Pennsylvania Chiefs of Police Association, the Western Pennsylvania Chiefs of Police Association and the Allegheny County Chiefs of Police Association. The son of a former Chief Justice of the Supreme Court of Pennsylvania, Mr. Zappala obtained his undergraduate degree from the University of Pittsburgh in 1979 and his law degree in 1984 from the Duquesne University School of Law.

### **Allison Harnden, Nighttime Economy Manager, City of Pittsburgh**



Since 1996, Allison Harnden has provided consultation services to assist 50 cities in 23 states to plan, develop, manage and police their nighttime economies. In her current role with Pittsburgh’s Office of Nighttime Economy, she works to improve life at night in neighborhoods citywide and implements strategies that nurture night commerce, address nightlife-related impacts and assist government to adapt to a city that operates at night.

Harnden serves as co-chair of Responsible Hospitality Institute and on the executive board of the newly formed Nighttime Economy Culture and Policy Alliance. She has co-authored Planning, Managing and Policing Hospitality

Zones: A Practical Guide and co-wrote a chapter on Designing Nightlife for Women in David Feehan’s book, Design Downtowns for Women; Men will Follow.

### **Councilman Bruce A. Kraus, Pittsburgh City Council**



Councilman Bruce A. Kraus, born and raised in the South Side, began serving as a member of Pittsburgh City Council on January 7th, 2008. Bruce proudly represents Pittsburgh's 3rd Council District while rounding out his duties as City Council President.

As Pittsburgh's first openly gay elected official, Bruce has been a strong proponent of civil rights issues, including the Allegheny County Human Relations Commission – which serves to combat discrimination in housing, public accommodation, and employment – and the City's first Domestic Partner Registry.

As a Councilman, Bruce has sponsored a diverse and comprehensive package of legislation over the years. In response to concerns of his constituents, Councilman Kraus introduced the Responsible Hospitality Institute's Sociable City Plan, which has worked to develop a comprehensive strategy to improve night life throughout Pittsburgh with an emphasis on public safety and transportation. Additionally, he sponsored the City's Social Host Ordinance, tightening measures to prevent underage parties and protect students and residents from unsafe conditions often created by these parties.

Council President Bruce Kraus is dedicated to fighting for the equal rights and well-being of all citizens of Pittsburgh. A truly community-focused public official, Bruce constantly strives to get to know the personal stories of the residents he represents. He is constantly working towards, in his words, "A city where all people are invited to our great common table, to share in an equal voice and have every opportunity to participate in the stewardship of their futures."

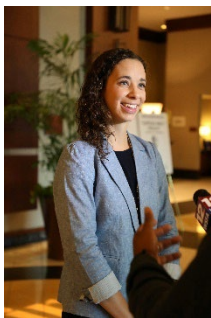

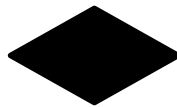

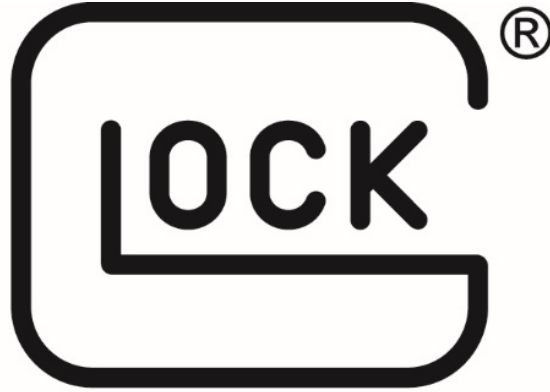
