Workshop 1- Modernizing Alcohol Regulatory Practices: Enforcement-Driven Results in Nebraska - Join us for a session showcasing how the Nebraska Liquor Control Commission (NLCC) transformed its enforcement capabilities through the implementation of the POSSE ABC software system. Since launching in May 2024, NLCC has seen a 137% increase in premise inspections, an 82% rise in Direct-to-Consumer reports logged and streamlined coordination with the Nebraska State Patrol (NSP) and Attorney General's Office—enabling faster case management and improved regulatory outcomes. The new system also introduced the POSSE Mobile app, giving inspectors real-time access to licensing and enforcement tools in the field. Operationally, NLCC has reduced license processing times by 75%, lowered staffing costs by 20%, and improved transparency and service to licensees. - Shannon Nyhoff, Legal/Enforcement Division Administrator, NLCC, Todd Suchsland and Nathan Jacobsen, NSP, and Joshua Collier, Business Development Director, Computronix

Workshop 2 – On the Scene: How TRACE Strengthens Alcohol Law Enforcement
The Target Responsibility for Alcohol-Connected Emergencies (TRACE) program is a partnership between the Texas Alcoholic Beverage Commission and state and local law enforcement agencies designed to expedite investigations of serious alcohol-related incidents at licensed establishments—such as DWI crashes involving significant injury or death, assaults tied to overserved patrons, or other critical events. Through a dedicated 24/7 TRACE hotline (operated via the Texas Parks and Wildlife Department), law enforcement can immediately notify TABC, enabling regional TABC peace officers to rapidly respond and begin investigative work while public safety concerns are still pressing. The aim is to bring TABC's enforcement expertise into urgent situations swiftly, improving case resolution and reinforcing accountability at licensed premises. –Lt. Workshop 1- Vermont Alcohol Compliance program – Dedicated to the Modern Innovations in the Retail and Manufacturing Industry - The Vermont Department of Liquor and Lottery's (DLL) Alcohol Compliance Program – Dedicated to the Modern Innovations in the Retail and Manufacturing Industry seeks to establish a 12-month compliance program. The program seeks to find if these changes in the retail sales market have any impact in sales to minors over traditional compliance. The planned measurable outcome will be the collection of 12 months' worth of data related to minor compliance in and around self-service checkout, comingled alcoholic and non-alcoholic beverages, & new RTD/Alcohol products that are derivatives on existing non-alcoholic products. – Sgt. Officer Galloway, a Texan, known nationally as the Tall Cop, has worked in substance abuse prevention and education for over 20 years. After playing Division I basketball and receiving his BA in Sociology from the University of San Francisco, he worked as a law enforcement officer for 18 years. His various assignments included: alcohol compliance and enforcement, CSI, DUI task force, officer mentoring, and field training officer. In 2007, Jermaine started the company known as "Tall Cop Says Stop™". The Tall Cop has conducted trainings in every US state and Canada and currently devotes thousands of hours each year to training professionals and

communities on drug and alcohol prevention, education, and enforcement. The Tall Cop is unique in that he spends hundreds of hours with "boots on the ground" highlighting drug culture in various communities. To date, Tall Cop has trained more than 800,000 professional and community members. He has trained across the U.S and in other countries such as Canada and the Bermuda Islands. The Tall Cop has conducted more than 8,400 community scans, identifying the drug culture and climate. His program, "High in Plain Sight", is a nationally recognized program, that provides training, education, and enforcement strategies for community substance abuse issues.

# Jim Diana, Lieutenant, Delaware Division of Alcohol & Tobacco Enforcement, NLLEA President



Lieutenant Jim Diana began his law enforcement career in October 1986 with the City of Wilmington, Delaware Police Department. He then served in the Uniform Patrol Division, Community Policing Unit, Criminal Investigations Division, and the Human Resources Division. In September 2007, Jim obtained the rank of Sergeant. In March 2008, he was transferred to the Human Resources Division where Jim became the Academy and Recruitment Supervisor for the Department. From March 2008 to May 2010, Jim was the Supervisor for three Wilmington Police Academies. He was also a member of the Wilmington Police Department Special Weapons and Tactics (S.W.A.T.) team for seven years. Jim received numerous department awards and commendations, to include the Delaware Chapter of the American Society for Industrial Security Law Enforcement Officer of the Year Award 1993. Jim retired from the Wilmington Police Department in May 2010 and became an Agent with the State of Delaware, Division of Alcohol and Tobacco

Enforcement (D.A.T.E.). In February 2012, he was assigned to the Delaware State Police, Division of Gaming Enforcement as an Investigator and remained there until September 2014 when he was promoted to the rank of Lieutenant where he supervised a squad of investigators until July 2024. With the legalization of marijuana in Delaware, Jim has been selected to lead D.A.T.E.'s Marijuana Enforcement Operations. Jim is a graduate of Brandywine College of Widener University in Delaware with an associate's degree in criminal justice earned in 1992. He is also a graduate of the Delaware State Police Leadership Development Program and recipient of the FBI Law Enforcement Executive Development Association (FBI-LEEDA) Trilogy Award.

In addition to his police work, Jim serves as a law enforcement liaison for the Delaware Special Olympics Summer Games Planning Committee and is an Executive Committee member of the Delaware Law Enforcement for Special Olympics.
