Dr. Leah Kaylor is a licensed clinical and prescribing psychologist and nationally recognized sleep expert who has spent over six years serving within the FBI, where she provides specialized consultation on sleep, stress, and human performance. Workshop 1 – OPMS and Kratom Products: Regulatory Compliance and Enforcement Considerations

Workshop 2 – Alcohol-to-Go: Closing the Compliance Gap

The expansion of alcohol-to-go laws increased youth access to alcohol by creating new retail access points that traditional minor sting models were not built to address. Three years of Texas-based research using the Community Alcohol-to-go Research Tool (CART) found an overall ID verification failure rate of 90% at restaurant walk-in pickup sites. The real vulnerability is the handoff point itself and a lack of resources to support consistent compliance checks. To address this, Texans for Safe and Drug-Free Youth partnered with the alcoholic beverage commission, law enforcement agencies, and community coalitions to develop an operational model that includes documentation tools and training to support compliance enforcement efforts at curbside, walk-in, drive-thru, and delivery settings since each presents distinct enforcement challenges. This replicable four-role compliance check model not only engages law enforcement but also includes retailers and community members. These cross-sector partnerships are vital in increasing consistent enforcement and compliance.

Workshop 3 - Organized Cargo Theft in Alcohol Distribution: Case Studies & Mitigation Strategies

Over the last several years, the alcohol and broader wholesaling industry has been increasingly impacted by the threat of theft and cargo loss from organized crime rings. Ranging from break-ins at warehouses to fraudulent documentation presented at pickup, this issue has the possibility to threaten billions of dollars in product and profit. Additionally, there are major concerns for industry members across the three tiers based on who can be considered liable for instances of theft. Furthermore, jurisdictional disputes and stolen products being sent overseas have resulted in difficulties in fighting back and protecting against this issue. Because of these reasons, the NLLEA Annual Conference serves as a preferred medium to convene public and private stakeholders for discussions on how these thefts have occurred in the past and best practices for bolstering defense in the future. The discussion will encompass key topics such as interagency collaboration, investigative practices and regulatory frameworks.

Workshop 1- Violent Crime Reduction – License to Interdict: Combatting Gun Violence at High-Risk Establishments

This presentation examines innovative approaches to reducing gun violence through focused enforcement at high-risk establishments. Our data-driven methods identify violence hot spots and

potential intervention points by analyzing data collected from local crime maps. We explore the critical distinction between probable cause and reasonable suspicion in the context of enforcement actions at these locations, with guidance for Agents making field observations and articulating legal justifications. The framework addresses tactical considerations to minimize risk to Agents and offenders. Tactics include vehicle suppression techniques and appropriate response to resistance procedures when conducting operations in potentially volatile environments. Implementation strategies emphasize strong documentation practices, to include detailed comprehensive report writing that withstand legal scrutiny. The presentation continues with best practices for providing effective court testimony that clearly conveys the legal basis for enforcement actions. Two case studies will be presented at length which resulted in federal convictions with prison sentences. The presentation concludes with a discussion about how these methods can be used in various other cities, and states across the country.

Workshop 3- Building the Future of Alcohol Regulatory Enforcement: Introducing Alcohol Compliance Training (ACT) and the National Trainer Network

The Alcohol Compliance Training (ACT) Program was developed by the National Liquor Law Enforcement Association (NLLEA) in partnership with the National Alcohol Beverage Control Association (NABCA) to provide a standardized, professional training curriculum for alcohol regulatory, enforcement, and compliance personnel nationwide. This session will introduce attendees to the ACT curriculum, training delivery model, and implementation strategy while highlighting opportunities for agencies to host training, send personnel to training, and contribute subject matter experts as certified ACT instructors. Participants will learn how ACT strengthens regulatory enforcement capacity, promoting consistency across jurisdictions, and building the next generation of alcohol regulatory professionals.

Workshop 4- State Alcohol Regulatory Funding: Findings, Thoughts, and Needs Over the Past Decade

In May 2024, J.T. Griffin and Pat Gagliardi authored *The Need for State Alcohol Regulatory Funding*, an updated analysis of a 2013 report on how states fund alcohol regulation. The update evaluates changes over the past decade, and highlights gaps and opportunities tied to alcohol sales. Drawing on data from multiple states, the report illustrates why a well-funded alcohol regulatory system is essential to public safety. While states differ widely in how they structure, fund, and administer alcohol regulation, several consistent themes emerge: the central role of law enforcement, the importance of preserving the three-tier system, and the need for stable, dedicated funding for state regulatory agencies.

This workshop will highlight the report's key findings, explore emerging funding trends and challenges, and outline practical considerations for policymakers and regulators. Participants will gain a clear understanding of why investing in state alcohol regulatory agencies is essential to public safety.

Workshop 1- Running the Table: The Ellis County, Kansas Fatality Source Investigation

This presentation will review a source investigation conducted by the Kansas Alcoholic Beverage Control (ABC) initiated on December 14, 2025, involving a fatality accident resulting in the death of a passenger and serious injury to the driver. Both were underage college students unlawfully in possession, and under the influence of alcoholic beverages. We will explore various obstacles confronted by the ABC investigators and creative investigative techniques used to overcome those hurdles. This presentation will discuss the unraveling of a pronounced chain of violations conducted by three license types and illegal social hosting that culminated in 30 criminal charges, 17 license actions, and felony charging of the driver. Through real-world case studies, attendees will examine common challenges, potential penalties for licensees, and proven strategies for presenting evidence and testimony effectively. The session will conclude with practical best practices that help ensure investigations withstand legal scrutiny and lead to successful enforcement outcomes. Whether you are new to administrative hearings or looking to strengthen your case preparation skills, this workshop will provide valuable insights to improve your effectiveness from investigation through adjudication.

Workshop 1 – Navigating Your Way Through Leadership

Workshop 2 – Transforming Alcohol Law Enforcement for the 21st Century

This presentation takes an honest look at how the Indiana State Excise Police rebuilt itself in 2026 — not by adding resources, but by finally organizing the ones it already had. Attendees will learn why a structure that asked every officer to handle everything from permit premise inspections, underage drinking details, to complex criminal investigations was holding the agency back, and how new executive leadership made the decision to change it. The presentation covers the creation of a dedicated Criminal Investigations Division, the development of a new uniform and plain clothes deployment model for large-scale public safety events, and the strategic partnerships and task force integrations that allowed the agency to maximize every resource available — from local and state law enforcement to federal agencies. Attendees will leave with a clear picture of what it actually takes to restructure a law enforcement agency while it is still running.

Workshop 3 – Overcoming Obstacles in the Face of Rapid Growth: What to Do When State Leaders Dramatically Increase Responsibilities?

After the 2025 legislative session, the Tennessee Alcoholic Beverage Commission was required to implement two new programs, adding significant responsibilities and a major expansion of its workforce. First, the commission inherited an unsuccessful intoxicating hemp program with a substantial license base from another state agency, and second, state lawmakers placed the commission in charge of the state's growing underage nicotine vaping crisis. This panel will provide valuable insight into:

- How to successfully navigate the legislative process by securing proper funding, staff, and other considerations.
- How to develop and execute a growth plan.
- How to implement new programs in a timely manner without neglecting current duties or compromising morale.
- Ways to avoid unforeseen issues and ways to adapt to challenges.
