Who Will be Speaking at MACC's 105th Annual Dinner?

Ryan Day

**Head Coach
The Ohio State University**



Sometime around 6:30 p.m. on January 1, 2019, Ryan Day had a whistle placed around his neck by retiring head coach Urban Meyer in front of the team after its 28-23 Rose Bowl Game victory over Washington. The head coaching tenure of Day at The Ohio State University had officially begun.

Technically, Day's first day on the job was Jan. 2, but that moment in the locker room at the Rose Bowl in front of 124 players, including more than 100 who will be a part of his first team, will have the lasting impact of origination for the 39-year-old from Manchester, N.H., who becomes just the 25th coach for a storied program that ranks second all-time in victories and will play its 130th season of football in 2019.

"It's an amazing feeling," Day said later on in the locker room. "To be the leader of such a special place, a special group of men, this program, Buckeye Nation ... it is an honor!"

A quarterbacks coach for the San Francisco 49ers in 2016 under Chip Kelly and in 2015 for the Philadelphia Eagles under Kelly, Day is in his third season overall at Ohio State and his 18th season as a coach in the NFL or collegiate ranks. He was

Ohio State's offensive coordinator and quarterbacks coach the past two seasons.

The impact he has had on the program in such a short time has been considerable. No school has had more passing touchdowns the past two seasons than the 90 that Ohio State's quarterbacks have thrown in that time. Ohio State also ranks seventh nationally over the past two seasons in passing yards per game and third in completion percentage.

Ohio State, in Day's two seasons, has won six championships: back-to-back Big Ten championships; two Big Ten East Division titles; the 2018 Cotton Bowl and this year's Rose Bowl.

In 2018 Ohio State ranked second nationally in total offense and passing yards, and No. 8 in scoring. It established Big Ten Conference records for offensive yards per game (535.6), passing yards (5,100), passing yards per game (373.0), touchdown passes (51), completions (396) and total plays (1,131).

Additionally, in 10 of 14 games this year, Ohio State had 500 yards or more of total offense, including 567 against the nation's top-ranked defense in a 62-39 win against No. 4 Michigan. Ohio State's offense was

fifth nationally in passing efficiency in 2017, sixth in scoring and eighth in total offense, plus it led the Big Ten in rushing, passing efficiency, scoring and total offense.

On the same day that legendary coach Urban Meyer announced his retirement – Dec. 4, 2018 – Day was named to succeed him.

The 105th Annual Meeting is scheduled for Monday, March 9, 2020, at the Dyson Baudo Recreation Center at Marietta College. Career Change Checklist: Are You Prepared?

If you're considering a job or career change, it's important to do some homework before you make the leap. Many benefits from your current position could be tied to specific dates and time frames. Gathering the right information can help you strategically time your exit and set yourself up for greater success.

1. Decide if you'd prefer to quit now or wait until you have an offer. This decision requires you to factor in how unhappy you are in your current position and whether you're able to live off your savings for a while. If you're in a traditional industry, such as sales, it might be better to find a new opportunity while you're employed. But if you're in high-tech, biotech, private equity, or a similar industry, there may be less risk in taking some time off.

2. Check your employment contract and noncompete agreement. Have a labor attorney review any legal documents you signed when you were hired to evaluate their terms and enforceability. Some contracts may require you to pay back relocation money, education grants, or bonuses if you don't stay for a certain period of time. Others include "golden handcuffs" that mean you will lose unvested options, restricted stock, deferred compensation, and other benefits upon resignation. Still others may require waiting for a specified length of time before taking a job with a competitor.

3. Review your retirement benefits. Check the vesting schedule for your employer's 401(k) contributions and profit-sharing contributions to see how long you have to work to claim your portion of the money. Many plans require you be employed on the last day of the plan year to get employer contributions for that year. You may want to wait until after the plan year ends before you terminate employment so you don't lose those contributions.

4. Check the terms of stock options, restricted stock, or other forms of non-salary compensation. You may want to delay your departure if a valuable number of options will vest in the near future. If

you're already vested, find out if you're still subject to the same trading windows and how much time you have to exercise your vested options once you resign. In many cases, options expire if they aren't exercised within a certain time frame—typically 90 days after your departure.

5. Manage your health insurance. If you don't already have a new position or if your new employer's health plan has a waiting period, figure out where you will get coverage to fill the gap. If your company has 20 or more full time employees, you'll be able to keep your current plan for up to 18 months after you stop working under the federal law COBRA (you'll likely have to pay your share and your employer's share of the premium). You may want to compare those costs with coverage available on the government's health insurance marketplace. Remember, if you live in a state with a health insurance mandate and you can afford but do not purchase coverage, you may have a tax penalty.

6. Spend your FSA accounts. If you put pretax money into a flexible spending

account (FSA), try to spend down the account before you resign. FSAs typically operate on a use-it-or-lose-it basis (though you may be able to extend with COBRA). In contrast, if you have money in a health savings account (HSA), that money is yours to keep.

7. Consider a group life and disability insurance conversion. If you have life or disability coverage through your employer, you may be able to convert your group policy to an individual policy. Often you have a short window after your resignation to apply with the insurer for continued coverage. This can be an especially good option if insurers consider you a risk because of your age or medical condition.

8. Consult a financial advisor. Whether you're planning to take some time off or go right into to a new job, an advisor can provide valuable financial guidance through the transition.

Did You Know.....



Flu season occurs in the fall and winter, peaking between late November and early March, and it's an epidemic

every year. The makeup of flu viruses can change from year to year, making it difficult to predict. Flu spreads through droplets when people sneeze or cough, and on surfaces. People are contagious one day before symptoms appear and up to a week after. When you don't feel well, it's best to take care of yourself and co-workers by staying home. And don't go back to work (or school) for at least 24 hours after a fever is gone.

- Membership in the Mid-Ohio Valley Safety Council for the current year.

- 1st & 2nd half Semi-Annual Reports must be completed and returned by the specified deadlines.
