Ladder Safety Best Practices

Now that Spring is here, and the weather is finally starting to stay consistent its time to break out the ladder and clean out those gutters. It seems like an easy task but can be very dangerous. Did you know that clogged gutters are the number one cause of basement water problems? When the gutters are clogged, the roof water can overflow and accumulate near the home’s foundation, allowing moisture to enter the basement. Time to pull out the ladder, but first we must review some safety tips to make sure that we complete the job safely.

Climbing a ladder seems simple but it is not as easy as it seems. Many workers are injured yearly getting on or off a ladder. Death has even occurred from falls after losing their balance.

The main thing to remember when using a ladder is to maintain three points of contact. Three points of contact is always either two hands and one foot or two feet and one hand on the ladder. You must make a conscious effort to maintain three points of contact.

Other items to remember, keep your weight between the rails, do not lean to either side as this can throw the ladder off balance. Ensure that the rungs and your boots are free from dirt and debris. Always remember to face the ladder when climbing up or down. Always let someone know that you will be using a ladder. Make sure that the ladder that you are using meets the manufacturers recommendation for the task that you are completing.

Ladders can be a very useful item but when safety procedures are not followed ladders can be a dangerous tool. Stay safe by being aware of ladder safety.

***If you choose to participate virtually, you are responsible for submitting your finished time to the Ohio River Sternwheel 5K Committee. You can do so by visiting The Ohio River Sternwheel Festival Facebook Page!**

Limited shirts will be available to participants registering on race day.

Should we not be able to run this race in person because of Covid-19, it will go Virtual and you will be informed on the Ohio River Sternwheel website and Facebook page as soon as that decision has been made and instructions on how to submit your time will follow. Everyone who is registered for this race will be moved to the virtual race. There will be no refunds.

We will be following the CDC's guidelines and recommendations on public health and safety measures for Covid-19.

All participants and spectators are required to wear a mask at all times when not running/walking in the race and practice social distancing of six-feet. Exceptions of wearing a mask are listed below as stated in the Director's Order for Facial Coverings throughout the State of Ohio, signed July 23, 2020, or as it may thereafter be amended...

The Order's exceptions include, but are not limited to: 1. The individual is under 10 years of age; 2. The individual has a medical condition, including respiratory conditions that restrict breathing, mental health conditions, or disabilities that contraindicate the wearing of a facial covering; 3. The individual is communicating or seeking to communicate with someone who is hearing-impaired or has another disability, where the ability to see the mouth is essential for communication; 4. The individual is seated and actively consuming food or beverage in a restaurant or bar; or 5. Facial coverings are prohibited by law or regulation; or 6. The individual is actively participating in broadcast communications.

To allow the use of whistles or to be heard when coaching or officiating, coaches and officials are not required to wear facial coverings during games and practices. Nothing in this Order prohibits a player, coach, or official from wearing a facial covering while on the field of play if it is practical to do so. Written justification must be immediately provided to local health officials, upon request, explaining why an athlete, student athlete, coach, or volunteer is not required to wear a facial covering when not on the field of play. At minimum, facial coverings (masks) should be cloth/fabric and cover an individual's nose, mouth, and chin.

Hand sanitizer will be readily available for use. Water, only, available after the race.

There must be no congregating before or after the race. Remember, social distancing! Awards will be mailed to the winners.

Anyone experiencing symptoms must stay home. According to the CDC, Covid-19 symptoms include fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, and diarrhea. This list does not include all symptoms. The CDC will continue to update symptoms as we learn more about Covid-19.
