- **II. Financial Report** Balance as of 5/10/2022 is \$4,504.71
- **III. Partner Reports**
 - **A.** City of New Castle Mayor's Office Shawn Anderson presented information packet titled <u>A Proposed Hometown Blueprint Plan 2027</u>. Looking for college intern. Have used services of PA CareerLink for candidates to fulfill enforcement position. Search is ongoing.
 - **B.** County of Lawrence Commissioners No one present
 - C. Regional Chamber of Commerce Paul Bucciarelli spoke regarding Forward Lawrence County to revitalize County. Will be doing three video testimonials with new growth in the area. May 18th will be a workforce focus group meeting from 11:00am-1:00 pm. Mixer being held on May 25th FLY (Forward Lawrence County Young Professionals). Golf outing is being held June 6th and still looking for foursomes to play. Leadership Program in conjunction with PSU Beaver will be held October May.
 - **D. Tourist Promotion** Janet Falotico spoke regarding school program in Pre-K through high school students. Pre-K through 3rd grade Flat Larry coloring and being displayed at Pizza

- Joe's. Older students' fun facts and bucket lists. National Tourism Week saw partnerships with neighboring counties and offered \$100 gift cards to encourage new growth and opportunities among the counties.
- **E. PA CareerLink** Matthew Geiger spoke regarding youth summer program involving internship and paid work experience from ages 16-24. One available program to employers is 50% wage reimbursement for employee on the job training. Also tuition assistance up to \$8000 grant for students who qualify. Possible job fair in conjunction with Mercer County.
- **F. New Visions** Jeff Feola provided information regarding online campaign for beautification of downtown. Once funds can be obtained of \$2500 there is a pledge to match that amount. In addition, when \$5000 is reached there is an additional \$1000 available for total of \$6000. June 4th will be planting of flowers downtown. The recent Market in the Mall was a success with 75 vendors. May 28th will be the Color Run. HomeTown Summer Concerts will be starting on June 24th with 5 additional concerts to follow. These concents are diverse in music, gender and color. At this time, still looking to raise at least \$2000 more through sponsorships. Starting June 24th and running through end of October will be Hometown Growers & Makers Market with 35-40 venders. This will be held weekly on Saturdays from 8:00am 12:00pm
