Highlights of England, Scotland & Wales

DAY 1: OVERNIGHT FLIGHT

DAY 4: EDINBURGH - YORK

Today head south to **York**, founded in AD 71 & rich in Roman, Saxon & Viking history. 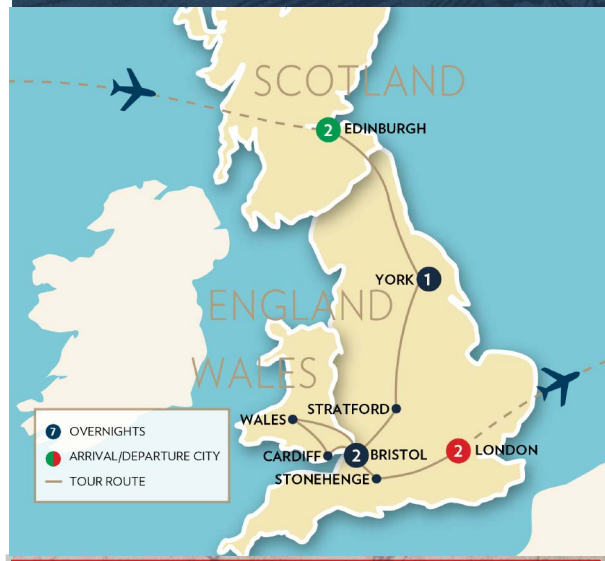
