Electrification - Driver Education Program	<p>The goal of the Electric Vehicle (EV) Driver Education Program is to empower the next generation of drivers through a driver education course offered at public high schools across its service territories. The driver education program aims to improve access to information via driver education EV curriculum and materials, strengthen the network of allies who can support EV education and adoption, improve access to electrification benefits, and lower barrier to adoption for qualifying schools through financial support regarding charging equipment installation and EV purchases. To achieve program objectives, implementers will need to develop EV Driver Education Program materials, launch the EV Driver Education Program, track and report on the EV Driver Education Program, integrate and manage Trade Ally efforts at participating schools and coordinate with the Trade Ally and Customer Service Program.</p>	Jun-23
Electrification - Community Engagement Consultation Program	<p>Ameren Illinois, in support of planning a more sustainable future, is seeking assistance spreading the benefits of electrification across entire communities via the CEC (Community Engagement Consultation) Program. The CEC program will enable communities to develop individualized transportation electrification plans for the future and implement those plans using the many resources available including direct support from Ameren Illinois for equity investment eligible and/or low-income communities.
