FLORIDA TOURISM DAY



This week, several CFHLA members and community leaders traveled to Tallahassee, in support of Florida Tourism Day. This annual day is devoted to bringing together industry leaders and partners from across the state, to visit with our elected leaders in Tallahassee and to advocate on behalf of the tourism and hospitality industry. We also had a chance to educate many of our leaders on the important issues facing the hospitality and tourism industry. This includes the long-term funding and continuation of <u>VISIT FLORIDA</u>, protecting the Tourist Development Tax (TDT) for its intended use in tourism marketing, ensuring that "shared lodging" businesses practice the same safety standards as traditional lodging, data privacy and more.

We also received some great news this week, regarding the continuation of **VISIT FLORIDA**! On Tuesday, the Florida House of Representatives passed <u>HB 489</u> (by State Representative Linda Cheney) in its first committee stop – the Tourism, Infrastructure, and Energy Subcommittee - and the bill is now scheduled for its final committee hearing next week. <u>SB 434</u> (by Senator Ed Hooper) has also passed its first committee and if approved by the next House and Senate committees, the companion bills will be ready for a final vote on both the House and Senate floor. Under this bill, the repeal date for VISIT FLORIDA and the Division of Tourism Marketing would be extended until at least October 1, 2028 (the proposed Senate date is October 1, 2031).

Thank you to all of our members and partners who supported this collaborative statewide effort, and we appreciate our elected and appointed leaders who took the time to meet with us and listen to our concerns!
