## CFHLA Salutes Hospitality Heroes for Responding during Hurricane Milton

On behalf of CFHLA, we'd like to salute our Lodging and Allied Members for their heroic responses during Hurricane Milton. There are so many stories about our tourism and hospitality partners stepping up to make a difference when individuals and families really needed help.

Many hotel and resort managers lowered prices on nightly stays or waived pet fees to help families evacuating out of harm's way. Employees quickly shifted to adapt to guests' changing needs. Hotels found ways to host dozens or hundreds of pets at the same time.

The team at the <u>Hilton Orlando/ Altamonte Springs</u> stepped up to make sure individuals staying in shelters also received hot meals. The catering department worked with <u>Seminole County Emergency Services</u> to provide food at five shelter locations throughout the county. The hotel team prepared enough food for **450 individuals to eat six meals each**. Our thanks go to General Manager Jaclyn Lorigan and her team for their strong efforts.

## Orange County Convention Center Brings Almost \$4 Billion in Economic Impact to Central Florida Economy

Did you know the <u>Orange County Convention Center</u> (OCCC) generates about \$3.9 billion in economic impact for the Central Florida economy each year? A recent study by <u>PFM Group Consulting</u> (PFM) revealed this significant increase, which highlights the Center's robust business activity.

PFM conducted its study based on data through 2023, and this included direct, indirect and induced impacts.

"We are steadfast in our mission of being an economic engine for the Central Florida region and infusing our local economy with new business and tourism opportunities," said OCCC Executive Director Mark Tester. "This study confirms that we are working in alignment with our mission and that the business conducted at The Center of Hospitality is positively impacting Orange County communities."

The PFM study also found 28,100 individuals are employed both directly and indirectly because of activity at the OCCC. It is also reported that an estimated 1,200 local businesses depend on the OCCC's event activity in full or in part. Additionally, the facilities directly supported by Convention Center activities, such as hotels, restaurants, offices, etc., generate about \$28.9 million in tax revenue for Orange County Schools during 2023.

Mayor Dyer Lays Out his Vision for the Future of Downtown Orlando in 2024 State of Downtown Address

This week, CFHLA and our members were excited to hear from Orlando Mayor Buddy Dyer as he laid out his vision for the future of downtown Orlando during the 2024 State of the Downtown Address. The event was held at the <u>KIA Center</u> and it was hosted by <u>Downtown Orlando Partnership</u>.

Here are just a few of the major highlights:

- Convert Magnolia Avenue from a one-way street to a two-way street, filled with shops, restaurants and walkways.
- Create a public park with a boardwalk, green space and playground at Lake Lucerne.
- Change parts of Orange Avenue into a two-way street with a center turn lane, medians and ride sharing pickup and drop off zones.
- The Canopy Park would cover four blocks underneath Interstate 4, with a combination of natural and technology features.

The vision for the future of downtown Orlando will also focus on making sure it is easy to get around in downtown; that there are many parks; and that there is something for everyone in downtown Orlando.


