**CFHLA PAC AND PC IS 17 FOR 21, AN 81% SUCCESS RATE ON
GENERAL ELECTION NIGHT**

ORLANDO, Fla. (November 06, 2024) – Today, the **Central Florida Hotel and Lodging Association's (CFHLA) PAC and PC Board of Directors** congratulated the following 17 endorsed state and local candidates, who won their respective 2024 General Elections Tuesday night.

CFHLA's endorsed candidates won 17 out of 21 races, an 81% success rate. Every PAC endorsed candidate who ran for the Florida Senate and the Florida House was elected in the General Election. The additional candidates we supported ran for Orange, Osceola and Seminole County Commissions, Orange County School Board, Orange County Supervisor of Elections, Orange County Tax Collector, and Osceola County Property Appraiser.

The **Central Florida Hotel and Lodging Association's Board of Directors** also passed a resolution, strongly opposing Florida Amendment 3, Recreational Marijuana, which failed to pass in the General Election. Additionally, the CFHLA PAC and PC supported the Orange County Half Penny Sales Tax Renewal for Schools and the Seminole County One Penny Infrastructure Sales Tax Renewal. Both local ballot questions passed Tuesday night.
