CFHLA Honors 2025 Charles Andrews Memorial Hospitality Award Recipient and Members of the Year

ORLANDO, FL (December 17, 2025) – The Central Florida Hotel & Lodging Association (CFHLA) held its **2025 Hospitality Gala** on Saturday, December 13th at the **Hyatt Regency Grand Cypress Resort**.

Nearly 1,100 CFHLA members, elected officials, and community leaders gathered for the Association's premier year-end event, which recognizes outstanding professionals whose leadership, service, and dedication continue to elevate the Central Florida hospitality and tourism industry. Honors presented during the evening included the Charles Andrews Memorial Hospitality Award, Lodging Member of the Year, Allied Member of the Year, and Engineer of the Year.

The evening's highest honor, the **2025 Charles Andrews Memorial Hospitality Award**, was presented posthumously to **Mr. David Siegel**, founder, president, and CEO of **Westgate Resorts**, and accepted by members of his family, including Jacqueline Siegel, David Siegel Jr., and Daniel Siegel. Named in honor of CFHLA's first Board Chair, Charles Andrews, this award represents the Association's most prestigious recognition.

Mr. Siegel established Westgate Resorts in 1982 with its first property on an orange grove he owned in Kissimmee, Florida. Under his visionary leadership and determination, Westgate Resorts grew into the largest privately held timeshare company in the world and one of the largest resort developers in the United States. This included more than 13,500 rooms at 22 resorts across the United States. Before his passing in April 2025, he announced an expansion of more than 44 resort destinations under the VI Resorts by Westgate brand.

Over the course of his career, Mr. Siegel embodied the entrepreneurial spirit that helped transform Central Florida into one of the world's premier travel destinations and built Westgate Resorts into the largest private employer in Central Florida.

While Mr. Siegel will be remembered for his successful business ventures, his influence extended far beyond. In 2013, Mr. Siegel was inducted into the Central Florida Hospitality Hall of Fame by the University of Central Florida and earlier this year, the American Resort Development Association (ARDA) honored Mr. Siegel with its prestigious Lifetime Achievement Award.

Furthermore, his philanthropy and advocacy left an enduring mark on families and organizations throughout the region. After the passing of his beloved daughter Victoria in 2015, Mr. Siegel's life mission radically changed toward solving the nation's drug epidemic. He founded Victoria's Voice Foundation to honor Victoria and advocated zealously for the widespread availability of Naloxone, lobbying Congress and raising awareness on this important issue. As a military veteran, Mr. Siegel donated more than 28,000 complimentary vacations to members of our armed services as a thank you for their service to our country. This year, the Westgate Foundation distributed grants of \$1.5 million to community-focused organizations across the United States.

Additionally, CFHLA would also like to congratulate several outstanding members of the hospitality community who received the 2025 Lodging, Allied, and Engineer of the Year awards at the Hospitality Gala.
