1.Get Basic Information and Assistance

There are multiple agencies in NE Indiana that can assist you with all your business questions. The Wells County Department of Economic Development serves as a clearinghouse for business information. Whiley they do not provide Business start-up counseling, there are a host of agencies in NE Indiana that can assist you.

2. Create a Business Plan

A business plan is like a roadmap, it shows you where you are in relation to where you want to be. May businesses fail without a business plan, and furthermore, lenders require one prior to being considered for a loan.

3. Determine Business Type

All corporations are State charted and must file Articles of Incorporation with the Secretary of State. More information is available from the Secretary of State. inbiz.in.gov

4. Determine Business Name

Choosing a name is important. In addition to making sure that the name describes your business clearly, you need to ensure that the name is available. The Certificate of Assume Business Name is available for a small fee at the Wells County Recorder's office.

5. Determine the Legal Structure

Several legal structures exist in the state of Indiana. Your choice of legal structure will affect your income taxes and personal liability. Assistance on the structure that suits your business should be sought from one of the business assistance organizations or from an attorney.

6. Select a Site and Determine Zoning Requirements

Determining Zoning requirements prior to signing a lease or contract is imperative. You must check with the county to see if the type of business you plan to operate is legal in the desired location. If operating from home, you must follow the requirements of the Home-Based Business Regulations. You can obtain more information by contacting:

7. Operating a Home-Based Business

You must check with the Decatur Office of City Planning to see if the type of business you plan to operate is legal in the desired location. If operating from home, you must follow the requirements of the Home Occupations Regulations.

8. Get Tax Information

Several types of taxes may be levied on business including income tax, employment tax, and other fees.
