# Important issues for County Road Association of Michigan during 2023-2024:

#### State-Level Issues:

The strength of the County Road Association (CRA) of Michigan comes from 83 counties' commitments to speak with a unified voice on issues impacting local roads, bridges and rights-of-way, as well as road agency operations. Some of those recent issues include...

- Advocating for additional road funding immediately as well as advancing discussion of a milagebased user fee.
- Equity of fund distribution and preservation of the state's Michigan Transportation Fund Act distribution formula with the introduction of new road funding.
- Telling the story of road commissions with emphasis on innovation and collaboration across county lines.
- Telling how Michigan's new road funding dollars are being used to facilitate transparency, trust and future funding.
- Strengthening relationships with other statewide governmental associations and private organizations in the service of Michigan's county transportation system.

- Protecting county road agencies' ability to apply mineral brine for dust control and winter maintenance without onerous and unnecessary regulations proposed by the Michigan Department of Environment, Great Lakes and Energy.
- Ensuring county road agencies continue to receive funding for the state highways they have taken ownership of due to a jurisdictional transfer as the from the Michigan Department of Transportation.

## **National-Level Issues:**

- Communicating to members the many changes and new opportunities with federal funding in the Infrastructure Investment and Jobs act.
- Working with the University of Illinois-Chicago and US Fish and Wildlife Service to meet
  upcoming rules and regulations related to the Monarch butterfly while giving county road
  agencies the flexibility to properly maintain the road rights-of-way.
- Maintaining the safety and integrity of the county road right-of-way as broadband entities begin widespread deployment using \$42.45 billion in Broadband Equity Access and Deployment funding.

## Ideas/concerns to share with other NACE Members:

- Maintaining and increasing funding for county road agencies while removing unnecessarily restrictive guidelines prohibitive to timely, efficient completion of road work.
- Seeking improved communication/engagement by NACE to Michigan county members.
