### A NOTE FROM OUR PRESIDENT

## **NEW SECTION! HIGHLIGHTED STUDENT**



Our highlighted student this quarter is Casey Judge. She is a 2<sup>nd</sup> year PhD student in Environmental Science at Iowa State University. Casey has just been named Acting Student Representative for the SWS North Central Chapter. In addition to this position, she is also the Chair-Elect of the SWS Women in Wetlands Section, and on the Social and Outreach Committee of the Iowa State University Ecology, Evolution, and Organismal Biology Graduate Student Organization.

### WHAT ARE YOUR PRIMARY RESEARCH INTERESTS?

My research is primarily focused on nutrient dynamics in Conservation Reserve Enhancement Program (CREP) wetlands located in the Des

Moines Lobe region of Iowa. Specifically, I am looking at the production of methylmercury in these sites.

#### HOW DID YOU BECOME INTERESTED IN WETLAND SCIENCE?

I studied marine biology in high school and developed a strong interest in that field of study, however I also have very strong ties to the Midwest. Wetland science gave me a way to research water in a variety of environments- including the primarily agricultural state of Iowa.

## WHAT DO YOU LIKE TO DO IN YOUR SPARE TIME?

Quilting, wheel pottery, hiking, kayaking and other water sports.

# DO YOU HAVE A MEMORABLE FIELD OR LAB STORY TO SHARE?

I found myself deep in a thick stand of cattails—all at least 2 feet taller than my head, searching for a spot to take a water sample. As I walked, with all my field sampling stuff loaded into my backpack, I began to get a little creeped out by my lack of visibility. I wasn't 100% sure how far from the road I had gotten. I finally found a spot to take a sample, and stepped gingerly to limit how much I stirred up the sediment. Carefully, I got my sample collection bottle ready, and had just started to crouch down when I heard a rustling through the cattails like something running right at me! Convinced the landowner had a guard dog who decided I shouldn't be there (or was it a rabid wolf?), I spun around (completely mucking up the water and destroying my sample location), but the sound kept coming from behind me! After a few spins I realized the sound was my backpack brushing against the cattails. So I set off to find a different sample location. And that, ladies and gentlemen, is how random sample locations are picked.

### **SWS NCC ANNUAL MEETING**

Save the date: September 8-11, 2016 @ the University of Akron Field Station and the Cleveland Museum of Natural History.

September 8-11th, 2016, our North Central Chapter will hold our annual meeting concurrently with the Ohio Wetland Association's Wetlands Summit and the Cleveland Museum of Natural History's Conservation Symposium. This unique collaboration includes educational opportunities and fun field trips throughout Northeast Ohio.

Events will start at Noon on Thursday September 8<sup>th</sup> at The University of Akron Field Station with field trips to local wetlands. On Friday, activities will move to the Cleveland Museum of Natural History (CMNH) for a full day of lectures and activities as part of their Conservation Symposium. Saturday will involve guest speakers from the Ohio EPA and USEPA about status and trends in local and national wetlands. We will also have concurrent sessions to hear about research from members in our NCC region, as well as other learning opportunities. Saturday evening we will have a formal dinner and celebration of Ohio Wetland Association's 25<sup>th</sup> anniversary.

On Sunday, in addition to our NCC meeting, there will be choices of field trip sessions. Attendees will have the opportunity to share their knowledge of wetland plants, with a special focus on vegetation identification. We will have formal discussions on wetland conditions at various wetland types during our excursions.

Northeast Ohio sports a number of high quality wetlands, including fens and bogs, as well as a solid wetland restoration community. Come learn about these wetlands, discover the impact glaciation had in this region, hear stories of successful wetland restoration efforts in this highly-population region, and meet other wetland professionals and enthusiasts.

We are investigating potential credits towards PWS certification renewal for meeting attendance.

# **Submitting Abstracts**

The Ohio Wetland Association (OWA) and the Society Wetland Scientists – North Central Chapter (SWS-NCC) invite the submission of abstracts to share research at the joint meeting of the OWA and SWS-NCC held September 8 – September 11, 2016, in Northeast Ohio. There will be oral presentation sessions on Saturday, September 10, 2016 with a poster session immediately following. Speakers are allowed 15 minutes for presentation plus 5 minutes for questions. Speakers are expected to present analyzed

results and conclusions from their work. Poster presentations may display preliminary research or projects where data have yet to be collected and/or analyzed.

If you wish to submit an abstract for an oral presentation or poster, please email a title, authors, and an abstract (200 words or less) to Julie Nieset (jenieset@illinois.edu) by July 1, 2016. For oral presentation submittals, if there is more than one author, indicate with an asterisk who will be giving the talk. Submittals will receive confirmation email of receipt of abstract. The presenting author will be notified by July 15<sup>th</sup> of acceptance.

All presenters are responsible for their own event registration. For poster presenters, there is also an additional opportunity to present posters as part of the Cleveland Museum of Natural History Conservation Symposium held Friday September 9, 2016.

## **Travel Awards**

SWS student members who submit abstracts, complete an application, and attend the meeting are eligible to compete for a \$200 travel grant. Two grants will be awarded. # **New Wetland Screening and Delineation Requirements**

On **June 1, 2016**, the Department of Natural Resources will require full implementation of the "Wetland Screening and Delineation Procedures" guidance. This guidance establishes a revised process requiring customers applying for storm water, CAFO (Concentrated Animal Feeding Operations), and waterway and wetland permits to submit a verified wetland delineation when wetlands are present in or adjacent to a project area. This guidance was developed to facilitate a more streamlined permit review because wetland boundaries will have been addressed on a project site prior to permit application submittal. The wetland review process will be uniform statewide, ensuring consistency amount the three most frequently used permit programs.
