February Legal Tip

Don't Bank On It

In Construction Contractors' Survival Guide, Tom Schleifer bluntly advised: "You're not a bank." But trying to collect often proves more difficult than performing the work. Consider as fair warning the Alaska Supreme Court's recent decision in GeoTek Alaska, 354 P.3d 368 (2015).

There, a second-tier subcontractor (GeoTek) contracted with a subcontractor (DSI) on a federal project. DSI had bonding difficulties (which apparently GeoTek knew), resulting in the general contractor (Jacobs) waiving DSI's payment bond requirement in lieu of a plan to require sub-tier releases and withhold increased retainage. Contracts were signed and work started. Ultimately, Jacobs paid DSI without requiring sub-tier releases or withholding retainage. GeoTek performed but went unpaid.

GeoTek filed for arbitration against DSI and Jacobs. Jacobs refused to participate, arguing it did not have a contract with GeoTek and, even so, could choose to reject arbitration under its contract with DSI. At arbitration, DSI settled out and assigned its rights against Jacobs to GeoTek. The arbitrator issued an award in GeoTek's favor against the not-participating Jacobs. GeoTek then tried to confirm the arbitration award in court for purposes of collection, which Jacobs successfully defeated.

GeoTek appealed to the Alaska Supreme Court, which agreed with Jacobs. The Court held that Jacobs could reject arbitration. It added that Jacobs owed GeoTek no duty to require DSI to provide a payment bond, warn GeoTek that a bond was not provided, or follow its releases and retention plan with DSI.

By not obtaining the normal protections before work started, GeoTek unwittingly became "a bank." It is a cruel reminder that trouble tends to flow downhill on construction projects. Contractors, particularly sub-tiers, must always watch the money and preserve ways to collect.


