# IMPORTANT! RACE NEUTRAL DOT/DBE PROGRAM UPDATE

The recent granting of a Race-Neutral DBE Goal for Alaska projects was a giant leap forward for Alaska contractors. It means a number of things that will make your job easier and not more complicated. With a raceneutral program, it means:

- The 8.46% goal does not apply for each project, but across all projects over the course of a year.
- The women owned business that were excluded by the waiver from counting will now count towards the overall goal.
- The Plan Holders Self-Registration List is still an important portal for you to make contact with DBE firms interested in bidding to you on projects.
- You will not be denied a contract award because of the lack of a Good Faith Effort.

This link of FAQ's from the DOT Civil Rights Office may better help you understand more about what this means.

Thanks to the sincere efforts of AGC contractors in working with the DBE program in recent years we have been able to make significant improvements in this program. To keep this program in place and continuing to make improvements, we need you to keep up your efforts.

Our program in Alaska is the envy of most other states. Keep up the good work!
