



AIDEA Welcomes Ambler Access Project Milestone



Authority Receives Record of Decision from BLM

The Alaska Industrial Development and Export Authority (AIDEA) has received its Record of Decision (ROD) from the Bureau of Land Management, the lead federal agency evaluating the <u>Ambler Access</u>

Project. "Today's announcement comes after years of rigorous study, more than a hundred public meetings, and dedicated support from Alaskans who believe in responsible economic development projects," said AIDEA Board Chairman Dana Pruhs. "This long–sought development of the road and mining district represents tremendous potential for economic growth, diversification, and job opportunities for Alaskans, along with revenue expected to the State and local governments for decades."



Final Federal Environmental Review Shows Pebble Can Be Developed Responsibly

Pebble Partnership CEO Tom Collier hailed today's publication of the final Environmental Impact Statement (EIS) for the proposed Pebble Project by the U.S. Army Corps of Engineers (USACE) as one of the most significant milestones thus far for the Pebble Project: "Today was really fifteen years in the making. From the beginning, we dedicated the time, resources and technical work to ensure we had a project that could be done responsibly, be done without harm to the Bristol Bay fishery, and provide meaningful contributions to the communities closest to the project. After an extensive, rigorous, and transparent review process the USACE has concluded the Pebble Project meets that mark. This is the same federal review process that has brought Alaskans decades of North Slope development and a host of other resource development projects that were resisted every step of the way by opponents of responsibly developing Alaska's resources that now provide jobs and economic activity for thousands of Alaskans.
