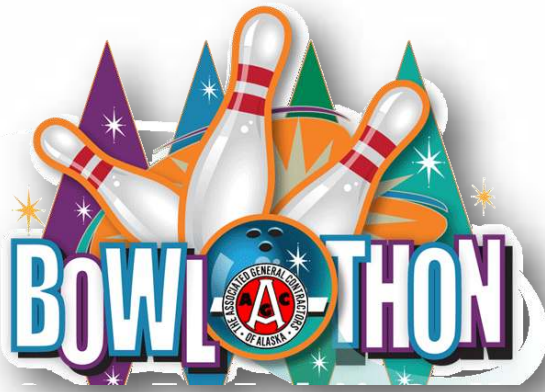

Kake Access Road Project

IRIS Number Z696070000

The Alaska Department of Transportation & Public Facilities (DOT&PF) proposes to construct an unpaved road with inter-visible turnouts on northern Kupreanof Island.

The Kake Access Road would construct approximately 13.5 miles of new road, incorporate approximately 21.6 miles of existing unpaved road, and construct a new boat launch. The project will begin at the intersection of Goose Lake Road (Forest Service Road 6030) with Forest Service Road 6040 and end at a boat launch accessing Frederick Sound near the mouth of Twelvemile Creek.

The purpose of the proposed Kake Access Road project is to provide increased recreational and subsistence opportunities on Kupreanof Island within the U.S. Forest Service Petersburg Ranger District managed lands.

The DOT&PF plans to use the Construction Manager/General Contractor (CMGC) project delivery method to assist in the development of the design incorporating innovative materials and methods, and to construct the project in a manner that minimizes impacts, reduces risks, and provides cost savings through efficient scheduling and utilization of construction materials.

DOT&PF invites contractors to a meeting on January 7th, 2020 from 1:00 p.m. to 3:00 p.m. at DOT&PF Headquarters located at 3132 Channel Drive (Room 140) Juneau, AK to learn more about the contractor selection process, CMGC, and the Kake Access Road project.
