PTAC NOTICE: SAM UPDATE

In the May 2018 PTAC newsletter, an article was posted regarding notarized letter requirements for new System for Award Management (SAM) registrations. What was not reported is A NEW REQUIREMENT FOR ALL UPDATE AND RENEWALS EFFECTIVE APRIL 27 2018.

GSA is requiring all SAM users to provide (via snail mail) an original hard copy, notarized letter identifying the authorized Entity Administrator. This requirement went into place on March 22, 2018 for new registrants. Effective April 27, 2018, existing registrants are now required to submit such a notarized letter confirming their authorized Entity Administrator before they can update or make changes to their SAM registration. Be aware because of this new requirement, activation may take up to a few weeks instead of a few days.

These letters are required to be submitted to the GSA Federal Service Desk in hard copy to the following address:

Avoiding Fines through Safe Digging

On April 12, ENSTAR and the Southcentral Alaska Utilities Association hosted the Third Annual Safe Digging Conference at the Crowne Plaza Hotel in Anchorage. The event was attended by more than 120 Anchorage-area contractors and excavators. Attendees saw presentations from Forrest Roy (ML&P); Brandon Field (AKOSH); Mike McCurtain (ENSTAR); and Dave Mulligan (PHMSA). The presentations emphasized that following safe digging practices is the key to worker safety and public safety on job sites. These practices include: calling 811 two days before digging; respecting locates (no digging within tolerance zone, no piggybacking); and having a proper exit plan when trenching. ENSTAR also introduced changes to damage claims for 2018; triple charges will now be assessed for every damage caused by gross negligence. Examples of gross negligence include: no locates, operating machinery within the tolerance zone, and attempts to conceal damages. Below are a few more details:

The conference was a joint effort between Southcentral Alaska Utility Association (SCAUA) and ENSTAR Natural Gas Company. The goal was to update contractors on digging safely around utilities and prevent damages. A few highlights from the presentations:

- While on a downward trend, third party damages to gas lines still happen at a higher rate in Alaska than in the lower 48 (see below for graphs).
- 1/3 of gas line damages in 2017 could have been prevented had 811 been called by the damaging party.
- The federal government's Pipeline and Hazardous Materials Safety Administration (PHMSA) is the enforcement agency in Alaska and reminded attendees of the state and federal regulations:
 - Excavators MUST call 811 before digging
 - Operator marking within 2 days of notification
 - Exemption less than 12-inches for agriculture
 - 24 inch tolerance zone, dig with care
 - 15 day ticket life
 - Notify operator of damage

 - **❤** Fines \$50-\$1000 (PHMSA federal will be \$200k- \$2M)
 - •Project owner responsibilities include but not limited to include safe digging practices in contracts, screen contractors, confirm locate ticket (no piggy-backing), confirm markings; confirm relocates, etc.
- Data shows that when a locate request (811) preceded an excavation, damage was avoided 99% of the time.
- 2018 ENSTAR Damage Policy Changes:

ENSTAR will commence assessing treble damages as authorized by Alaska Statute 42.20.030

Fact sensitive inquiry

Gross negligence exhibited

Past company damage history –multiple damages

Prior notification regarding digging unsafely

Not calling 811 for Locates

Public awareness resources
