New Qualified Business Income Deduction: Implications for Flow-Through Construction Businesses FREE Lunch & Learn Oct. 30th, 2018

As part of the Tax Cuts and Jobs Act a new deduction of up to 20% of qualified business income was enacted. This deduction allows owners of flow-through businesses (partnerships, S corporations, and sole proprietorships) to reduce their tax burden if certain criteria are met.

Tommy Orr, Senior Manager, National Tax Office with BDO will lead the presentation and the focus will be on how construction businesses and related entities can benefit from this deduction. 
