Nationwide, every 6 minutes an underground utility line is damaged because someone decided to dig without first calling 811.

Alaska has one of the highest rates of damage to underground utility lines in the nation – 3 times the national average for damage to natural gas lines.

As of October 1, 2016, all excavators in the state of Alaska are subject to Federal excavation standards defined in 49 CFR Part 196 against an excavator who damages a regulated hazardous liquid or natural gas pipeline in Alaska. Federal civil penalty levels are up to \$205,638 for each violation for each day the violation continues with a maximum civil penalty of \$2,056,380 for any related series of violations.

Alaska State Law requires excavators to give notice of proposed excavation so facility owners can mark the location of their facilities.

This is for your safety, the safety of those around you and to protect the buried infrastructure.

Calling 811 does not cost you, the excavator, any money. To avoid enforcement action, make sure you do the following Every Dig, Every Time:

- Call Before You Dig
- Wait the required time
- Respect the Marks
- Obey the Tolerance Zone
- Dig Safely

"Liberty Energy Project"

The Liberty Energy Project - Liberty is the largest proven, but undeveloped, light-oil reservoir on the North Slope, with an estimated 80-150 million barrels of recoverable oil. Peak production of between 60,000 and 70,000 barrels/day is projected within two years of initial production. The field has a life expectancy of 15 to 20 years. Located 15 miles east of Prudhoe Bay in Foggy Island Bay, Liberty Island will sit about six miles offshore in 19 feet of water. The 9.3-acre, gravel island will take an estimated two years to construct, creating good-paying jobs for Alaskans. Development of Liberty will help offset declining oil production on the North Slope and contribute to increasing the life span and efficiency of TAPS. Come learn more about this project and participate in the public process.
