# STORM CHASERS BEWARE!

## Unlicensed Storm Repair Work Now a Felony

**A**labama experiences more than its share of severe weather events. These events sometimes result in catastrophic damage to homes, businesses, and lives. Although it is difficult to predict exactly where these storms may hit, it is predictable that following the damage will come a different kind of disaster. This secondary disaster is the arrival of unlicensed, unscrupulous storm chasers who descend on communities hardest hit and take advantage of Alabamians in their most vulnerable hour of need.

The Alabama Home Builders Licensure Board works tirelessly during those times to try to police out the bad actors and allow the legitimate contractors

to help heal the communities. Unfortunately, some of the bad actors slip through the cracks and leave Alabama with homeowners' money and nothing to show for it. Up until now, the only thing a district attorney could do is issue a misdemeanor warrant on the individual, but in reality, no one ever gets extradited back from another state on a misdemeanor warrant for home repair fraud. That is until now.

Over the past few years, the HBAA has worked closely with Rep. Matt Simpson to tighten Alabama's home repair statute and make the crime a felony. That work culminated with the Alabama Legislature's passage of a sweeping bill that makes unlicensed contracting in

an area covered by a state of emergency declaration a felony crime. It covers not only unlicensed home builder activities, but includes HVAC, electrical, and plumbing activities as well. This is a huge victory of Alabama's consumers and its legitimate contractors. It cannot be overstated how much time and effort Rep. Simpson put into developing this legislation and making it a reality. His dedication will help stave off that secondary disaster and allow Alabamians to rebuild their lives with confidence that their contractor will not skip out with their hard-earned money, but if they do, they will be brought back to Alabama to face justice.

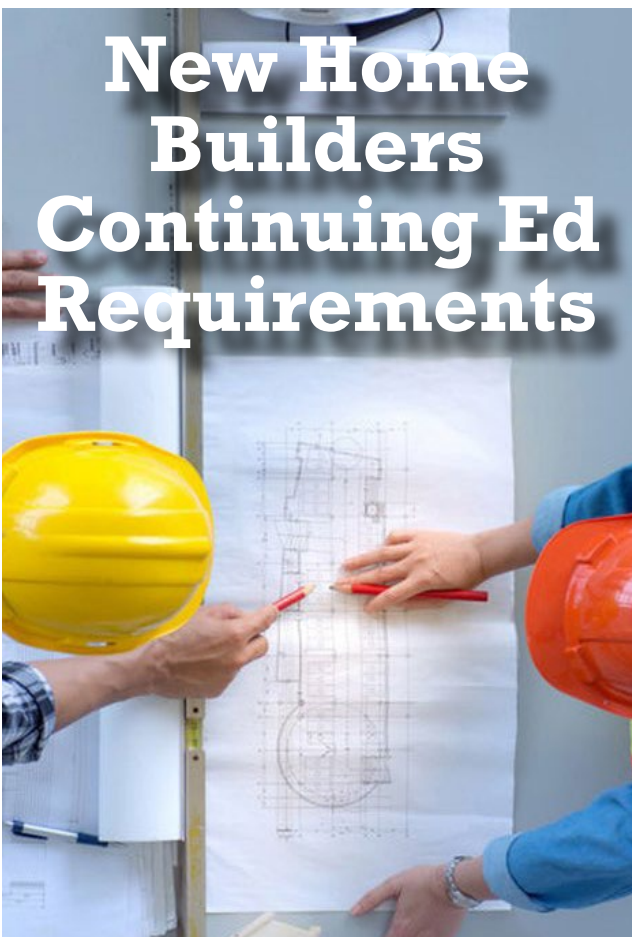

## New Home Builders Continuing Ed Requirements

**Beginning in the 2022 renewal year**, all licensees and/or designated qualifying representatives for a corporation, limited liability company, or partnership under the age of 60 must obtain six (6) credit hours of continuing education before being issued a 2022 license.

Must complete at least two (2) credit hours of approved Alabama specific courses such as Contracts, Business Organizations and Law, Financial Management, Consumer/Customer Relations and Management, State of Alabama Home Builders Licensure Law and Regulations and Risk Management: Avoiding Common Violations.

**Exemptions:**

- Military who were activated/deployed for 90 consecutive days during a licensure year

- Licensee submitting renewal application for the first time.
- Licensee experiencing a personal hardship (Must be approved by Continuing Education Committee).
- Licensee who has taught continuing education approved by the Board.

Inactive licensees must complete six (6) hours to enter active status. Licenses can carry over up to six (6) into the following licensure year.

Must complete continuing education on or before Nov. 30th to avoid fifty (\$50) administrative late fee.

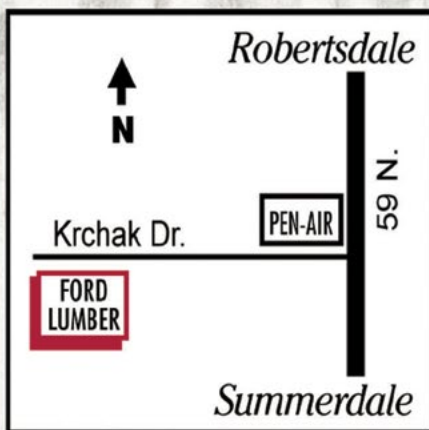
