

Marriage License Information

- Both parties will need to go to the Lincoln County Clerk's Office at 225 W Olive Street, Room 201 in Newport
- Marriage licenses are issued Monday-Friday, 8:30 am—4:00 pm
- The application process takes approximately 15 minutes
- A marriage license fee is \$60. They accept CASH ONLY
- There is a 3-day waiting period before the license becomes effective. However, the waiting period can be waived for an additional \$10 fee.
- Additional \$7.75 for a certified copy of the marriage license
- These fees do not include any type of ceremony, which is required
- Both parties must be 18 years of age (or 17 accompanied by a parent who will sign a consent form). A valid drivers license or ID card will be required for identification.
- If either party has been divorced within the past six months, a copy of their final divorce decree will need to be provided
- A wedding license is good for 60 days
- A blood test is not required
- Two witnesses are required for wedding ceremonies

Marriage License Information

- The Clerk's Office can schedule wedding ceremonies performed by the Lincoln County Clerk. The ceremonies are performed in many locations, both indoor and outdoor (including on the beach).

- The County Clerk is available on most weekdays and Saturdays for wedding ceremonies.

Call the park (or nearest park to the beach location) to discuss your plans, possible permits, fees and insurance requirements. Depending on the event, you may need a [special use permit](#) for non-traditional activities.

A non-traditional activity is an activity, gathering or use of park properties, ocean shore or other recreational area that is not defined in park area rules and regulations.



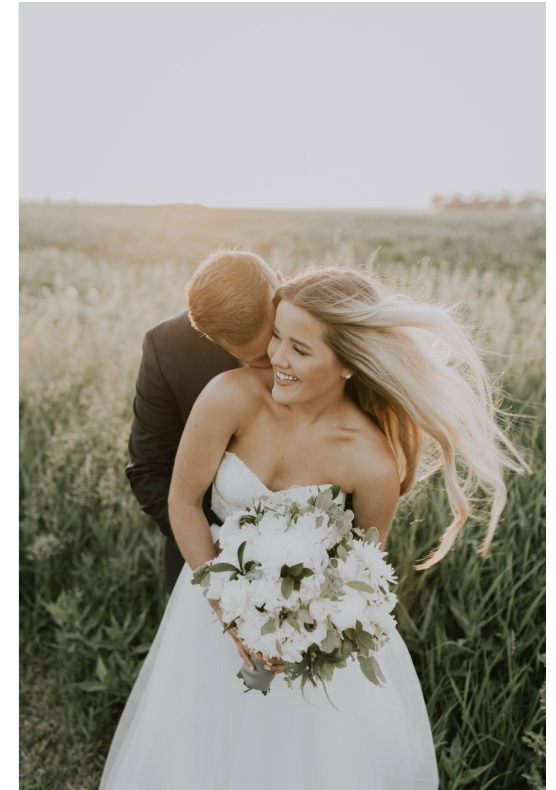
