Food Vendor Application Participation Terms Agreement

Product: Homestead Days is a family-oriented event, featuring food, commercial, art, and craft vendors. Spaces are limited and will be on a first come, first serve basis. Every effort is given to limit overlap of items sold, allowing for a unique appeal to our visitors. Food vendors must meet inspection by Nebraska Department of Agriculture, Bureau of Dairies, and food, prior to start of operation. All applications must be complete.

Location and Hours of the Festival: Located at **Charles Park, or Chautauqua Park** - Beatrice, Nebraska. Placement of vendor as determined by event coordinators at Beatrice Area Chamber of Commerce will be communicated to vendor prior to festival.

Saturday, or Sunday, June 21, 22, 2025. Vendors are allowed to set up Friday evening, with advance arrangements made.

Charles Park Show Hours: Saturday: 11:00 AM - 5:00 PM

Chautauqua Park Show Hours: Saturday: 11:00 AM - 6:00 PM & Sunday: 11:00 AM - 5:00 PM

Vendors must be open during show hours, but can be open earlier and stay open later if appropriate. If vendor is unable to be open during show hours, advanced approval must be given by Beatrice Area Chamber of Commerce. Please indicate your preference of locations for Saturday. Vendor location subject to change at the discretion of the Beatrice Area Chamber of Commerce.

Booth: *Booth space is available on a first come, first served basis.*

Placement is based on requests, submitted on the application form. No subletting of space or part of space is allowed. Booth rental fee is \$25 for one day and \$35 for two days. Prior to event, a map will be available for review. Map is tentative and is subject to change. Booth spaces are not drawn to scale.

Application & Notification: *Applications must be received and paid for by June 6, 2025.*

If you are rejected or placed on our waiting list, you will be refunded.

Insurance: All vendors must show proof of liability insurance, with the Beatrice Area Chamber of Commerce and City of Beatrice listed as secondary insured.

Cancellation Policy: No refunds will be given after June 6, 2025

Electricity is limited, request must be noted on application form.

Tents, tables, chairs, etc. are not provided. There are no water hook-ups, but water is available nearby.

No early breakdowns permitted. Before leaving, vendor is required to clean the area around their booth.

No vehicles are allowed to be driven in the park area in Charles Park.

Responsibilities: *Vendors & exhibitors must check-in at the information booth, prior to set-up.*

Vendors are responsible for providing tables, chairs, display materials and heavy duty extension cords as needed. This is an outdoor show and Beatrice Area Chamber of Commerce is not responsible for loss or damage of any kind. Beatrice Area Chamber of Commerce is not responsible for theft or damage to exhibitor's trailer or tent, display, or goods. All exhibitors should be able to protect their merchandise from inclement weather. No rain dates scheduled. All exhibitors are responsible for collecting and reporting sales tax to the State of Nebraska Dept. of Revenue. Exhibitors may not sell or consume alcoholic beverages on site.

We strongly encourage no smoking; if you must, please refrain from doing it in front of or near event guests.
