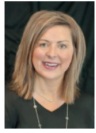

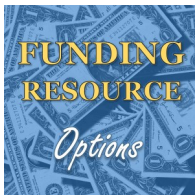

# 6 WAYS TO PREPARE TO RE-OPEN

## 1 BUILD A COVID-19 PLAN

Prepare a plan of action. This plan will later be used in marketing efforts to show your customers that you care. Call it your COVID-19 Safety Plan. Include cleaning and sanitizing schedules, new protocols, safety procedures, social distancing, and options that include both indoor shopping and curbside. Be sure to continue reaching consumers virtually with Facebook Live, videos, webinars, photo updates, and more.



## 2 SOCIAL DISTANCING

By now, you've been to a store that has stickers on the floor showing you where to stand, saw the signs that limit the number of entrants, noticed some doors are marked entry and some exit, workers are using gloves and have on face masks, and you've even seen plastic shields in front of the counters. You need to consider similar procedures. Start gathering necessary supplies and signage to accommodate your COVID-19 plan.



## 3 CLEANING SCHEDULE

Consumers will notice if your store is clean, organized, and safe to enter. Make sure you are rebuilding your cleaning plan and have all the necessary items needed to do so. Build a new schedule and add it to your daily calendar. Make sure your staff is fully aware of the new procedures - have staff meetings before re-opening to go over your plan. Build in inspection times and checklists for quality control.



## 4 MARKET YOUR PLAN

As businesses begin to re-open, consumers will look for those locations who have clearly marketed their COVID-19 Safety Plan. Big franchises, as well as other small businesses who have already remained open, have executed this very well and for some it has even increased their business. When you begin to market that you're back open, follow it up with your new plan. Consumers will notice and make sure they are entering a safe environment.



## 5 RESPECT THE PROCESS

This process of re-opening will constantly adjust as our leaders evaluate the current environment. Just as many people who are ready for business to be open as usual, there are others who will remain overly cautious for quite some time. If you cater your plan to the cautious, consumers will be more open and respect those procedures. The lack of a COVID-19 Safety Plan will undoubtedly lose some consumers. The faster you adhere to the safety protocols, the faster you will get back to business as usual.

# GUIDANCE FOR REOPENING YOUR BUSINESS FROM THE CENTERS OF DISEASE CONTROL AND PREVENTION

## *Relevant Executive Orders:*

2020-18 Stay Home, Stay Healthy, Stay Connected

2020-33 Returning Stronger

2020-12 Prohibiting the Closure of Essential Services

## **FOR CUSTOMERS - Following the Centers for Disease Control and Prevention (CDC) guidance, under all circumstances, the following precautions should be followed:**

- Stay home if sick
- Order online or use curbside pickup if possible
- Protect yourself while shopping
  - Stay at least 6 feet away from others while shopping and in lines.
  - Cover your mouth and nose with a cloth face covering when you have to go out in public.
  - When you do have to visit in person, go during hours when fewer people will be there (for example, early morning or late night).
  - If you are at higher risk for severe illness, find out if the store has special hours for people at higher risk. If they do, try to shop during those hours. People at higher risk for severe illness include adults 65 or older and people of any age who have serious underlying medical conditions.
  - Disinfect the shopping cart, use disinfecting wipes if available.
  - Do not touch your eyes, nose, or mouth.
  - If possible, use touchless payment (pay without touching money, a card, or a keypad). If you must handle money, a card, or use a keypad, use hand sanitizer right after paying.
  - After leaving the store, use hand sanitizer. When you get home, wash your hands with soap and water for at least 20 seconds.

***To the extent possible, retail establishments need to properly facilitate allowing their customers to follow these guidelines.***

## **FOR BUSINESSES - The Department of Health Services recommends the following additional steps be taken by retail establishments:**

- Maintaining physical distancing.
- Operating with reduced occupancy and capacity based on the size of the business location with special attention to limiting areas where customers and employees can congregate.
- Implementing comprehensive sanitation protocols.
- Continuing to provide options for delivery or curbside service even if a location allows customers inside the store.
- Closing fitting rooms at clothing stores, meeting rooms or other enclosed spaces accessible to customers that do not allow for appropriate physical distancing.
- Implementing symptom screening for employees prior to the start of their shift.
- Considering offering cloth face coverings to employees and visitors to wear.

## RETURN STRONGER

*A Gradual Step-By-Step Plan For Reenergizing Arizona*



### Starting May 4th

Retail businesses will be allowed to sell goods through delivery service, window service, walk-up service, drive-through service, drive-up service or curbside delivery provided they establish and implement sanitation and physical distancing measures



### Starting May 8th

Retail businesses can resume expanded in-person operations permitted they implement social distancing and sanitation measures established by the United States Department of Labor or the Arizona Department of Health Services.



### Resuming Elective Surgeries

Starting May 1, hospitals and outpatient surgical centers are resuming elective surgeries, with assurances that these facilities have adequate supplies and PPE. To date, over 1,090 facilities and counting are eligible to resume elective surgeries.



### Dine-in

GOAL: resume dine-in operations in May, with guidance being developed in coordination with public health officials and industry leaders to be provided in the days ahead.

### What's next:

**Further guidance:** phased in based on the recommendations of CDC and health experts through May and June.

**Advanced notice:** prioritizing giving businesses and citizens time to plan and adjust.

**Public health first:** increasing tests, following the facts, and continuing physical distancing.

## GUIDANCE FOR BARBERS AND COSMETOLOGISTS

*Pursuant to EO 2020-34 Building on COVID-19 Successes*

*Resuming additional business operations for barbers, cosmetologists and dine-in restaurants*

**Following the Centers for Disease Control and Prevention (CDC) guidance, under all circumstances, the following precautions should be followed by people utilizing barber and cosmetology services. To the extent possible, these providers should take measures to ensure that customers may follow these guidelines:**

- Stay home if sick.
- Protect yourself while visiting salons, spas, and barbershops:
  - Stay at least 6 feet away from other patrons.
  - If you are at higher risk for severe illness, you should avoid visiting barbers and cosmetologists. People at higher risk for severe illness include adults 65 or older and people of any age who have serious underlying medical conditions.
  - Do not touch your eyes, nose, or mouth.
  - If possible, use touchless payment (pay without touching money, a card, or a keypad). If you must handle money, a card, or use a keypad, use hand sanitizer immediately after.
  - After leaving your appointment, use hand sanitizer. When you get home, wash your hands with soap and water for at least 20 seconds.

**FOR BUSINESSES - The Department of Health Services recommends the following additional steps be taken by barbers and cosmetologists:**

- Maintain physical distancing, to the extent possible.
- Provide and require employees to wear masks when possible.
- For salon treatments that require touching someone's face, provide and require employees to wear gloves when possible.
- Provide access to soap and water for handwashing or an alcohol-based hand sanitizer at stations around the store, salon or spa for use by employees and clients. Require employees to wash hands immediately before and after providing client service.
- For treatments/appointments that don't require touching the client's face, clients should be encouraged to wear masks for their protection.
- Operate with reduced occupancy and capacity based on the size of the business location with special attention to limiting areas where customers and employees can congregate.
- Wipe any pens, counters, or hard surfaces between use or customer.
- Implement comprehensive sanitation protocols.
- Implement symptom screening for employees prior to the start of their shift.
- Consider offering cloth face coverings to employees and visitors to wear.
- Consider operating by appointment-only to manage occupancy levels.
- Arrange waiting areas, service areas, and break rooms to provide for appropriate physical distancing and sanitize areas regularly between use.
- Consider posting signs advising customers and employees of expectations and guidance.
- Consider not charging late/cancellation fees if someone cannot make their appointment due to illness.
- Train all employees in the above safety actions.

## GUIDANCE FOR RESTAURANTS PROVIDING DINE-IN SERVICES

*Pursuant to EO 2020-34 Building on COVID-19 Successes  
Resuming additional business operations for barbers, cosmetologists and dine-in restaurants*

**Following the Centers for Disease Control and Prevention (CDC) guidance, under all circumstances, the following precautions should be followed by people dining in restaurants. To the extent possible, restaurant establishments should take measures to ensure that customers may follow these guidelines:**

- Stay home if sick.
- Consider ordering food for delivery or curbside pickup if available.
- Protect yourself while dining at restaurants:
  - Stay at least 6 feet away from others while dining.
  - When you do dine-in, consider dining during off-peak hours (for example, early morning, mid-afternoon, or late night).
  - If you are at higher risk for severe illness, continue to use takeout and delivery and avoid dine-in services at restaurants. People at higher risk for severe illness include adults 65 or older and people of any age who have serious underlying medical conditions.
  - Do not touch your eyes, nose, or mouth.
  - If possible, use touchless payment (pay without touching money, a card, or a keypad). If you must handle money, a card, or use a keypad, use hand sanitizer immediately after.
  - Wash your hands with soap and water or use an alcohol-based hand sanitizer before you eat and again when you are finished.
  - After leaving the restaurant, use hand sanitizer. When you get home, wash your hands with soap and water for at least 20 seconds.

**Following the Centers for Disease Control and Prevention (CDC) guidance, under all circumstances, the following precautions should be followed by restaurants providing dine-in:**

- Consider assigning duties to vulnerable workers that minimize their contact with customers and other employees.
- Enforce hand washing, covering coughs and sneezes.
- Develop standards for the use of non-medical grade masks or cloth face coverings by employees when near other employees and customers.
- Ensure adequate supplies to support healthy hygiene practices for both employees and customers including soap, hand sanitizer with at least 60 percent alcohol (perhaps on every table, if supplies allow), and tissues.
- Consider posting signs on how to stop the spread of COVID-19, properly wash hands, promote everyday protective measures, and properly wear a face covering.
- Intensify cleaning, disinfection and ventilation practices.
- Wash, rinse, and sanitize food contact surfaces, food preparation surfaces, and beverage equipment after use.
- Avoid using or sharing items such as menus, condiments, and any other food. Instead, use disposable or digital menus, single serving condiments, and no-touch trash cans and doors.
- Wipe any pens, counters, or hard surfaces between use or customer.
- Train all employees in the above safety actions.

**The Department of Health Services recommends the following additional steps be taken by restaurants:**

- Maintain physical distancing, including limiting parties to no more than 10.
- Operate with reduced occupancy and capacity based on the size of the business location with special attention to limiting areas where customers and employees can congregate.
- Implement comprehensive sanitation protocols, including increased sanitation schedules for bathrooms.
- Continue to provide options for delivery or curbside service even if a location offers dine-in.
- Implement symptom screening for employees prior to the start of their shift.
- Consider offering masks to wait and host staff.
- Restaurants should sanitize customer areas after each sitting with EPA-registered disinfectant, including but not limited to:
  - Tables
  - Tablecloths
  - Chairs/booth seats
  - Table-top condiments and condiment holders
  - Any other surface or item a customer is likely to have touched
- Avoid instances where customers serve their own food.

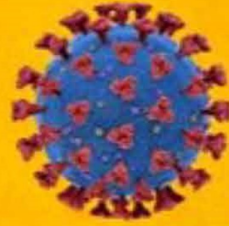

## WHAT TO DO

---

- Create and implement an active screening plan including:
  - Location and staffing of the screening table
  - Signage to support the active screening process
  - Rules to allow or prohibit entry
  - Script for screening
  - Alcohol-based hand sanitizer available at the screening table
  - Handout explaining the changes
  - Develop sick policies, like work from home options

## SCREENING QUESTIONS TO CONSIDER

---

- Greet everyone entering the building with a friendly, calm, and reassuring manner.
  - “Good morning/afternoon! As you know, COVID-19 continues to evolve quickly. We are screening all employees for potential risks of COVID-19 to ensure the health and safety of everyone.”
- 1. Do you have any of the following symptoms: fever/feverish, chills, dry cough, difficulty breathing, or digestive symptoms such as diarrhea, vomiting, and abdominal pain?  
 Yes       No
- 2. Have you traveled within the last 14 days?  
 Yes       No
- 3. Have you had close contact with a confirmed/probable COVID-19 case?  
 Yes       No

## HOW TO RESPOND

---

- If the individual answers NO to all questions, they have passed the screening and can begin working.
- If the individual answers YES to any screening questions, or refuses to answer, they failed the screening. Keep the employee away from others and contact a supervisor for assistance.

## MESSAGES YOU CAN USE TO PREVENT SPREAD OF VIRUSES AND STAY HEALTHY

---

- Practice these healthy habits to prevent the spread of viruses:
  - Wash your hands with soap and warm water for 20 seconds. If unavailable, use an alcohol-based hand sanitizer with at least 60% alcohol.
  - Avoid touching your eyes, nose, and mouth with unwashed hands.
  - Cover your nose and mouth with a tissue when you cough or sneeze, or cough/sneeze in your upper sleeve.
  - Immediately throw away used tissues in the trash, then wash hands.
  - Clean and disinfect frequently touched surfaces, such as doorknobs, handles, light switches, tables, toilets, faucets, sinks and cell phones.
  - Avoid touching common surfaces in public places – elevator buttons, door handles, handrails, etc. Use elbows or knuckles to push buttons when you do not have a tissue or sleeve to cover your hand or finger.
  - Make sure others in your household, or anyone you are regularly in close contact with, follow these precautions.
