

Who is the SBAC?

The SBAC is a 501c6 organization laser-focused on nonpartisan small business policy at the federal, state, and local levels of government. Using policy committees & subcommittees, informational webinars, and issue-specific townhalls, we advocate for legislation that will improve the small business environment. In addition to our nonpartisan advocacy work, we also host various networking events that connect business owners to a common cause.

Who does the SBAC serve?

The SBAC is laser-focused on serving the small business community. Our mission is to enact policies that better enable and level the playing field for all. We are committed to being non-partisan and thus our footprint is much larger in the legislative forum.

What has the SBAC's done?

The SBAC was founded in 2010 and has had many advocacy victories. Our keystone victory was the lowering of LLC registration fees in 2017 from \$500 to \$150, allowing more entrepreneurs to launch new businesses and grow the Illinois economy.

We also claimed victory over the City of Chicago's complex public way use permitting process in 2021.

How does the SBAC help?

The SBAC is here to listen to the community and what you as a small business owner see, hear and experience every day. We can help your business understand and participate in amending small business legislation.



What is the Advocate Partner Program?



The Advocate Partner Program is how the SBAC assists local chambers. As part of this program, Chambers may have all their members automatically become General Members of the SBAC. This includes engagement in SBAC advocacy initiatives laser-focused on supporting small businesses and local communities through key advocacy newsletters, video updates, legislation-specific action calls, and town halls. Also included is the SBAC's partnership in the promotion of chamber-specific related events on social media.

We also work in a less formal manner by offering local chambers the chance to endorse our advocacy work as it develops. The endorsement might be in the form of a chamber's logo under a certain initiative, or a chamber's executive director's signature on an open letter to a lawmaker.

In 2021 alone, SBAC advocacy initiatives were endorsed 150+ times.

The Advocate Partner Program is a tool for your chamber. Through the program, chambers can offer advocacy services to their member businesses – at no cost. The SBAC is simply focused on growing our advocacy footprint so we can craft polices that benefit and improve the small business environment. The SBAC is not interested in "poaching" members from your chamber. This is a free service that seeks to benefit both the SBAC and the local chamber.
