#### **CONTEXT | COVID-19 Roadmap to Reopen**

- On May 20, 2021, the government released its <u>Roadmap to Reopen</u>, a three-step plan to safely reopen the province and lift public health measures based on the provincewide vaccination rate and improvements in key public health and health care indicators.
- The Roadmap to Reopen outlines three steps to easing public health measures.
- The province is scheduled to remain in each step for at least 21 days to evaluate any impacts on key public health and health system indicators. If at the end of the 21 days vaccination thresholds have been met, along with other key public health and health system indicators, then the province will move to the next Step.
- The following slides provide an overview of the public health and workplace safety measures in Step 3.



#### **PRINCIPLES | COVID-19 Roadmap to Reopen**

The principles for determining what is permitted in each step are as follows:

#### STEP 1



Resuming outdoor activities where risk of transmission is lower and limited indoor settings with restrictions

#### STEP 2



Further expanding outdoor activities and resuming limited indoor services with small numbers of people and with face coverings being worn

#### STEP 3



Expanding access to indoor settings, with restrictions, including where there are larger numbers of people and where face coverings can't always be worn

#### **Emergency Orders Under the Emergency Management and Civil Protection Act (EMCPA)**

- The-third provincial emergency declared on April 7, 2021 under s 7.0.1 of the *Emergency Management and Civil Protection Act* (EMPCA) ended on June 2, 2021.
- There are currently 3 Emergency Orders (EOs) in effect that were made under s. 7.0.2(4) of the EMCPA. EOs made under this section may be extended for up to 14 days at a time, by order of the LGIC.
- The following orders have been extended until July 28, 2021:
  - O. Reg. 305/21 (Regulated Health Professionals)
  - O. Reg. 55/21 (Compliance Orders for Retirement Homes)
  - O. Reg. 8/21 (Enforcement of COVID-19 Measures)

#### Orders Under the Reopening Ontario (A Flexible Response to COVID-19) Act, 2020 (ROA)

The expiry date for the 29 orders in effect under the Reopening Ontario (A Flexible Response to COVID-19) Act, 2020 (ROA) is currently July 19, 2021 and they may be extended for up to 30 days at a time, by order of the LGIC.
