ZARZAUR LAW, P.A. CONTINUES ONGOING COMMUNITY PARTNERSHIP WITH THE YMCA IN SUPPORT OF THE DEVELOPMENTAL "ZARZAUR LAW ZINGRAYS" SWIM TEAM'S THIRD SEASON.

PENSACOLA, Fla. (May 9, 2024) — In partnership with Zarzaur Law, P.A., the YMCA of Northwest Florida is excited to announce the third season of the Zarzaur Law "Zingrays" developmental swim team.

This team will provide a developmental opportunity for swimmers who have basic competence in the water but may not be ready for a competitive school or community team, or for families who may not be able to afford a traditional swim team. The team is under the direction of Regional Aquatics Director, Bonnie Steffensmeier. "Swimmers are required only to be able to swim safely across the pool to join the team." Said Steffensmeier "The swimmers will then continue to grow not only in their confidence in the pool but also in supporting their teammates and instilling safety and sportsmanship."

"We are very proud to continue our support of this developmental YMCA swim team," Joe Zarzaur, founder, and lead attorney at Zarzaur Law, P.A., said. "The Zarzaur Law Zingrays team allows all participants to grow and accomplish more than they ever thought they could, no matter their skill or economic level."

The 40-member team, made up of swimmers 4–18 years old, will practice at the Hunter Pool. Because of Zarzaur Law, P.A.'s sponsorship the cost to families is just \$100 for the summer. Additional financial assistance is available from the YMCA on a sliding scale if that fee is still out of reach.

"We are so excited to be entering our third year of this partnership with Zarzaur Law to build a positive experience for these kids. Being a member of the Zarzaur Law Zingrays has opened a door for so many of these swimmers—a door to skill development, confidence building, and learning teamwork. Now in year three, it's even more exciting to see team alums return to continue their journey," said, Andrea Rosenbaum, Director of Advancement of the Northwest Florida YMCA.

"Joe Zarzaur just gets it. He understands the importance of investing in kids and demonstrates it through his community support. We're so grateful for his trust in the Y to bring this experience to these families."
