June Andel talked to participants at both the Annual and Mid-Year Meetings in an effort to recruit them.

David Bearman recruited for ASIS and SIG/AH at conferences of the Museum Computer Network and the Society of American Archivists.

Other communications from Headquarters: Received a letter of commendation for our spring 1988 newsletter from Linda Resnik, May 5, 1988 [see attachment].

(15) Other comments about SIG activities:

Liaisons with related organizations: As of 1987, AH has a liaison with the World Brain / World Mind Group. For the past few years I have maintained liaisons with the Association for Computers and the Humanities, the Society for Conceptual and Content Analysis by Computer, and the Philosophers' Computer Network. Elizabeth Davis maintains a liaison with the Northeast Association for Computing in the Humanities. Member T.R. Girill was appointed to the nascent APA Committee on Computer Use in Philosophy. Because of my work on behalf of SIG/AH and ASIS, I was invited to speak at the conference of the American Philosophical Association (APA) in Washington in December 1988. At various times we have engaged in newsletter exchanges, e.g. with "Research in Word Processing News" and "Ontario Humanities Computing Newsletter".

These are typical of our outreach efforts of the past four years to break down artificial organizational and invisible college boundaries and to bring outsiders into our conference

programs and hopefully into ASIS itself.

We will intensify efforts to publicize our activities through related organizations and their newsletters.

Planning for 1988 Annual Meeting programs: We have three sessions planned for Atlanta: (1) Electronic Archives, (2) Issues in Art Information: Image-Text Integration, (3) What Philosophers Say Intelligent Systems Cannot Do (cosponsored with SIG/FIS) [see attachments].

Planning for 1989 conference programs: I am working on a program for the 1989 Annual Meeting on linguistic and intercultural barriers to the flow of information. If time permits, I would also like to pursue an idea I first proposed to SIG/CR in 1986: a session on "Subject Access to Fiction, Poetry, and Drama." Some libraries have constructed experimental computerized databases which provide in-depth thematic indexing of fiction, transcending traditional subject access to fiction.

Assuming that our proposed Chair-Elect Ellen Sleeter is approved, I am sure that she will have her own program ideas as well.

My general policy since I largely assumed responsibility for SIG/AH in October 1983 has been to put together imaginative and innovative programs and to promote research areas that have not been coherently pursued. Examples of my programs are Bibliometrics in the Humanities and Social Sciences (October 1984), 'Content Analysis' in the Humanities (October 1985), Personal Databases, the Online Organization of Text, and the Future of Scholarly Work (which utilized the hypertext concept before it became a household word) (October 1985), three sessions on philosophy and information science (October 1987). Other SIG/AH members organized programs on microcomputer applications in the humanities (May 1984), 'Artifical Reality' (Plenary Session and panel discussion, October 1984), Music as a Manipulative Medium (October 1986), videodisc technology (October 1986), the 'World Brain' idea (October 1987 and May 1988), and thesauri and semantic networks in art information (May 1988). These are the programs that I can recall offhand. We shall continue to think imaginatively and dream up exciting ideas.

Newsletters: Our next newsletter should be completed early in September and should include descriptions of humanities-related sessions at the Mid-Year Meeting, pertinent bibliographical references, and a continuing listing of humanities and information related organizations, at the very least. In the future, we will include book and software reviews as we did in 1984.

Recruiting: We plan to contact members who have dropped out since 1983 and encourage them to rejoin SIG/AH.

Mission description: Our revised mission description will soon be submitted to appropriate ASIS officials [see attachment].

Publications: We are looking into helping H.J.A. Goodman complete and publish his book on the history of the 'World Brain' concept.

Expert assistance: We have on occasion provided information and advice to persons interested in recent developments in a given area. For example, we received a call within the past few weeks from a music librarian at the Library of Congress wishing to know about recent developments in multisensory (graphics/text/sound) online systems. David Bearman has reported offering expert advice on numerous occasions.
