4a (Code:) (Expenses \$ 114,631. including grants of \$) (Revenue \$ 46,955.) Professional Development - UNA provides access to affordable training (UNA Credential, annual conference, advocacy essentials, and other timely topics) throughout the year that meets a variety of nonprofit, organizational needs throughout Utah. The overall hope is that nonprofit organizations operate at peak effectiveness after engaging in our training. In 2020, 572 people representing 125 organizations attended the conference. The UNA Credential program, which helps nonprofits gain best practices, and provides them the tools for long-term sustainability, served 227 leaders from 95 nonprofits across the state. Since 2015, we awarded 146 badges, and in 2020, 28 badges were awarded for completion of implemented best practices. (Continued on Schedule O)

4b (Code:) (Expenses \$ 40,315. including grants of \$) (Revenue \$ 134,780.) Member Services - UNA provides a spectrum of services that support entry level to seasoned nonprofit staff and volunteers. These services include technical assistance, group purchasing programs, access to cost effective health insurance and other administrative services (such as background check services and grant seeking database), information and research on nonprofit sector issues, and networking activities. At the end of 2020 UNA had 532 nonprofit members, 43 individual members, and 37 business members. Top membership serves include: The UNA Job Board where during 2020, 223 organizations posted an open position with a total of 813 jobs posted. Facilitated group Health Insurance where 63 nonprofits provided health insurance (through the UNA provided plan) to 1,423 humans.

4c (Code:) (Expenses \$ 126,742. including grants of \$) (Revenue \$ 5,700.) Advocacy Engagement - UNA provides avenues for nonprofits to understand how they can engage with elected officials, and the proper ways to advance their mission through advocacy. UNA hosts Nonprofit Day on the Hill, an event designed to bring nonprofits to Capitol Hill, and show them how they can engage during the legislative session. At this event, 39 organizations met with 7 state senators and 25 State Representatives. UNA provided timely information about Federal and State COVID relief dollars, and organized training for nonprofits so they could apply for PPP loans.

Throughout the course of the year, UNA provided various other learning opportunities for nonprofit professionals to network, learn from each other, and receive training. Some examples are: 75 attended a member orientation and 11 webinar recordings were provided with a total viewership of over 100 views. Overall, UNA had participation from 1,772 humans representing 554 organizations throughout the year. The COVID-19 pandemic forced UNA to move immediately to a remote workforce completely shifting all training and services online. The organization gained traction and attendance during this period with this shift in operations.
