ACCNJ Alert: Supply Chain Regulations

In an August 19 [Email Alert](#), we notified members ACCNJ, alongside AGC of America, has been monitoring the shifting price escalation of construction materials while actively seeking solutions to this national industry issue. With inflation raising construction materials and services by nearly 21%, USDOT wants to hear from you on how it should apply a sweeping expansion of "Buy America" requirements on construction materials for all federal-aid transportation projects. ACCNJ Alert: Objecting EEOC Data Disclosure

In an August 22 [Email Alert](#), we informed members a recent "Freedom of Information Act" (FOIA) request was initiated by an investigative reporter to make annual employment reporting data public for years 2016 to 2020. Companies who have previously filed these reports have an opportunity to issue written objection responses to the data's potential public disclosure.
