



WeSERV ANNUAL MEMBERSHIP DUES: WeSERV Membership Dues are billed and payable ANNUALLY by **January 1st**. Members are alerted via email, phone, and text notification. Online Dues invoices are typically available to view and/or pay beginning mid November. *Please Note: Paper invoices are NO longer mailed to members. Members are encouraged to pay online.*

Reminder: Under current IRS Rules, the portion of your 2026 dues used for lobbying is not tax-deductible as a business expense for income tax purposes. Those nondeductible amounts for 2026 Dues are NAR 35%; AR 0%; WeSERV 4%. The full amount of the NAR Consumer Advertising Campaign (\$45) qualifies as deductible for income tax purposes.
