Vendors wishing to sell food must submit a liability insurance policy. Time/Temperature controlled foods are not permitted inside the Indoor Vendor Market. Special requests can be submitted to the Toes in the Grand Committee for an exception with all approved permits and forms.

Indoor Market Vendors:

10x10 Booth Space – Member.....	\$200/space
10x10 Booth Space – Non-Member.....	\$225/space
Each Additional 10x10 Space - Member.....	\$150/space
Each Additional 10x10 Space – Non-Member.....	\$175/space

Indoor rates include pipe, drape, one 6 ft table, and two chairs. Electricity is \$20 per booth.

Outdoor Market Vendors:

10x10 Booth Space – Member.....	\$175/space
10x10 Booth Space – Non-Member.....	\$200/space
Each Additional 10x10 Space - Member.....	\$125/space
Each Additional 10x10 Space – Non-Member.....	\$150/space

Outdoor rates do not include tables or chairs. The fee is for space only. Vendors must use blocks and weights to hold canopies or tents down and no stakes are allowed. Generators must be approved for outdoor vendors. They are not preferred.

Set up time will be June 11th, 9 am – 5 pm and June 12th, 8 am – 11 am. All booths must be set up and ready to go by 11 a.m. on Friday, June 12th. Failure to comply will result in a potential vendor late fee. Security will be provided overnight Friday for both indoor and outdoor booths. You will be required to be open and have your booth staffed from 12 pm – 9 pm on June 12th and from 10 am – 9 pm on June 13th. We have entertainment on Friday and Saturday at the Expo Patio that will last until 9:30 p.m. If vendors move out early, the committee has the right to enforce an additional vendor fee. **Initial Here: _____**

Directions for vendor parking and setup will be released closer to the opening of the event. Early set-up on Wednesday, June 10th may be available if requested in advance.

Additional Vendor Fee for non-compliance is \$150 per booth space.

Guidelines & Regulations

Items restricted to sell: The Toes in the Grand Summer Kickoff Festival Committee has the sole and exclusive right to add additional items to the list before or during the festival. The Committee, in its absolute discretion, shall decide at any time, before or during the festival whether an item or product can be sold at a booth or on the premises. Should the Committee exercise this right and inform a vendor that an item or product cannot be sold; the item will immediately be removed from the booth or exhibit area and the festival premises. **Vendors must seek approval to distribute samples from their booth. Any food items must be approved, and appropriate liability insurance must be on file. This will be strictly enforced.**

Fire, theft, damage: The Toes in the Grand Summer Kickoff Festival Committee and/or the Grove Area Chamber of Commerce will not be responsible for loss due to fire, theft, or other damage regardless of the cause. The Toes in the Grand Summer Kickoff Festival Committee, the Grove Area Chamber of Commerce, and the City of Grove are expressly released from any loss, injury, or damage to persons or property. **Initial Here: _____**

Use of vehicles & trailers as booth space: Trailers will be allowed for outdoor booth space at the discretion of the Festival Committee. Photos of the trailer must accompany the reservation form. Space must be purchased to account for space larger than a 10x10 spot.

Failure to comply with regulations will result in the exhibitor being dismissed from the 2026 festival and future festivals. Final decisions are at the discretion of the festival committee.

Application must include payment and a copy of Oklahoma Sales Tax Permit, if you have one, to be considered complete. You will be reported to the Oklahoma Tax Commission as a participant and required to submit paperwork to reflect your sales and taxes collected from sales at this festival.

I, the exhibitor, agree to the terms on pages 1, 2, and 3 of this form and acknowledge, if accepted as a vendor, I will abide by all the terms set forth in this "Reservation Form" with no exceptions, and do hereby contract space for the 2026 Festival.
