Nerves of Steel, A Deeper Dive with Dr. Elko-Rm-102-A

Description: This program addresses life-changing concepts by explaining the step-by-step process necessary to guide you. Dr. Elko teaches you how to be mentally tough when times call for it, and how to stay focused on the things that are truly important.

Today's workplace, be it an athletic field, a business office, or our home, is more stressful than ever and people report being less able to handle their environment now than any time in history. In his approach, Dr. Elko discusses the strategy necessary to develop Nerves of Steel. He points out the importance of intrinsic motivation and how to keep those motivators in front of you at all times. Dr. Elko discusses how to focus using specific self-talk and how to identify your internal Voice of Judgment (V.O.J.) and how to internally respond to it. Finally, to retain the information taught in this program, Dr. Elko explains how to give away the very thing you need...your "68".

Topic Managing Workplace Conflict – Rm-102-BC

The negative effects of workplace conflict can include work disruptions, decreased productivity, project failure, absenteeism, turnover, and termination. Conflict can – and should – be managed and resolved. Conflict resolution must be based on a workplace culture of strong employee relations, fairness, trust, and mutual respect at all levels. This workshop will explore the causes and effects of workplace conflict and ways managers can act to address it before it gets out of hand. You will learn to identify your personal style in dealing with conflict and how to make it work best for you, gain effective communication techniques, and learn how to cultivate positive attitudes for working with others.

Commingling Paratransit and Other Trips in On-Demand Microtransit-Rm-101-C

Monday: 11:05-11:50 am (45 Min)

Description: This presentation will provide attendees with information and discussion on findings from TCRP Synthesis J-07/Topic SB-42: Operational and Service Factors When Integrating/Consolidating ADA Paratransit and On-Demand Services. This recent synthesis project focuses on current practices by transit agencies or other transportation-providing organizations in commingling paratransit and general public trips together in on-demand microtransit service. Types of paratransit trips in this topic may include those from the transit agency's ADA paratransit program or other types of specialized trips (e.g., older adults, Medicaid, human service transportation). The project gathered survey responses from agencies around the U.S. and Canada currently commingling different trips together in microtransit, then conducted case example research on five such integrations/consolidations to learn further details on commingling planning, policy, implementation, and results so far. The presentation will discuss examples of these integrations/consolidations along with notable practices and lessons learned from transit agencies and organizations. The intended audience for this session includes staff from transit agencies, local governments, and departments of transportation.

Learn how NEORide has leveraged the buying power of transit across the country.- Rm-102-A

Description: NEORide, a council of governments representing over 37 members in ten states, has reinvented coordinated purchasing. Their EZfare mobile ticketing system has created a pathway for transit agencies of all sizes to purchase a mobile ticketing system that alone would be cost prohibitive. EZfare will have 20 agencies live on the app by the end of 2025 and allows for agencies to customize their needs by offering visual validation, validators, ABT and EMV. Enhancing Urban Mobility through Collaboration and Advanced Technology for Smart City Collaboration-Rm-101-C

Monday: 1:30 -2:30 pm (60 Min)

Description: The integration of the Digital Intersection with cloud-based Transit Signal Priority reflects a forward-thinking urban transportation strategy. By utilizing real-time General Transit Feed Specification (GTFS) data, adaptive algorithms, Vehicle-to-Everything (V2X) technology, and centralized management, cities can establish a more efficient, reliable, and sustainable transit system, enhancing the overall mobility experience for their constituents. Successful implementation of these innovations necessitates collaboration among government agencies, transportation authorities, technology companies, and the public to build a comprehensive and integrated smart transportation ecosystem. Failure to establish connected systems may impede the rapid deployment and management of vehicles and intersection units, resulting in traffic congestion, interruptions, and challenges in maintaining the infrastructure. This abstract delves deeper into successful Advanced Traffic Management and Transit Signal Priority (TSP) implementations in the Northern California Bay area, emphasizing a holistic approach that considers the interplay between transit operations, infrastructure, connected and autonomous vehicles, safety, and community needs. Addressing these components collectively enables cities to develop public transportation systems that are not only more efficient and equitable but also enhance roadway safety for vulnerable users. This approach is poised to drive continuous advancements in the future. Results indicate that TSP can enhance efficiency by improving urban transit flow by up to 20%, mitigate delays by up to 40%, ensure transit signal adherence, and contribute to sustainability by limiting idle times, consequently reducing emissions by 19%.

Running on Empty - Understanding Fatigue as a Form of Impairment-Rm-102-A

Description: Fatigue is indeed a critical factor in road safety, and poor journey planning can significantly exacerbate this issue. In industries with high travel demands or shift-based work, managing fatigue becomes even more essential to ensure both employee well-being and public safety. People often make light of how little sleep they get on a regular basis; an overworked, over-tired condition has become the norm for many. But a good night's sleep is not just a novelty, it's a necessity. According to the National Safety Council, more than 43% of workers are sleep-deprived, and those most at risk work the night shift, long shifts, or irregular shifts. In addition, fatigue is estimated to cost employers \$136 billion a year in health-related lost productivity. Employers, especially in industries where employees are on the road or working irregular hours, can play a crucial role in mitigating fatigue. Additionally, technology and journey planning tools can aid in optimizing routes, scheduling adequate rest breaks, and monitoring working hours to ensure employees are not overexerted. Taking these proactive steps not only promotes safety but can also contribute to a more sustainable and productive workforce.

RED TINTED BUS LANES: AN OVERVIEW OF TCRP SYNTHESIS SD-07 RESEARCH - Rm-102-A

Description: This topic was submitted via TTA's website through the call for abstracts. This session will provide an overview of red-tinted bus lanes, how they have been designed and used in North America, their impacts on bus service, their maintenance performance, and relevant lessons learned by agencies that have implemented them and/or make use of them. The content of the session will come from the report for TCRP Synthesis SD-07, which is anticipated to be published around the time of the conference. The session would be applicable primarily to Texas transit agencies that have bus lanes, queue jump lanes, bus pullouts, and curbside bus stops that tend to get blocked by general traffic.

Financial Management, Oversight and Control - Rm-102-BC

Description: Transit system financial management and control are the responsibilities of transit system management. This is typically a combination of a general manager, financial officer, and accounting staff. However, transit system boards and/or elected officials are responsible for overseeing and controlling the organization's financial health. The financial documentation that board members should review and specific items that should be monitored will be explained. Potential pitfalls will be identified, which could lead to significant issues for the local transit system.

Making Zero Emissions Operations More Resilient - A Private Contractor's Perspective-Rm-103-AB

Description: MV Transportation is the largest privately-owned transportation company in North America, providing paratransit, fixed route, shuttle, and school bus services. MV operates for over 150 transit agencies, with 15 of those locations employing more than 200 zero emissions (ZE) vehicles, from automobiles to 60' coaches, including both battery electric and H2 fuel cell technologies. MV is departing from the passive top-down traditional practice of contracted operations in which the private operator is just a purveyor of transportation services to a collaborative approach where the company partners with agencies for efficient transitioning to ZE vehicles and infrastructure.

To this end, MV has been working with its partners on strategies to make daily operations more resilient. One of those actions is the analysis of the effects of temperature on range deterioration, energy consumption, and charging process. The results of this assessment have led to the development of summer and winter readiness programs to provide our

operations and maintenance managers with guidelines on how to prevent and mitigate the impacts of extreme weather on vehicles and infrastructure, thus minimizing disruptions of daily operations.

Usually, operation contracts for private companies only last a handful of years, which forces operators to become highly efficient and goal-driven to achieve the expected results in shorter times. This is leveraged with MV's geographical distribution and hyperlocalization in certain areas to use the sandbox of best practices to replicate successful experiences.
