#### **Low-Cost Transit Planning Resources for Rural and Small Transit Agencies – RM: 101**

**Description:** This presentation describes a transit planning process for rural/small transit agencies and provides information about readily available and inexpensive tools and data that can be used to inform rural/small agencies' transit planning. The tools are practical and informed by research.

The session also highlights foundational elements of a successful preventive maintenance program—whether maintenance is performed in-house or through a contracted provider—with an emphasis on protecting agency investments, supporting ADA compliance, and extending vehicle service life.

#### **RAPIDO: A Rapid-Response Framework for Crisis Management and Decision-Making in Transit – RM: 106**

**Description:** Transit moves fast, and critical decisions must move with it. This session introduces RAPIDO, a streamlined decision-making model built for high-pressure transit environments. Designed for transit supervisors, frontline leaders, control center and dispatch staff, operators, field supervisors, emergency management and safety teams, HR, training, workforce development staff, and new or emerging leaders, this session offers practical tools for real-world challenges. Christina Villarreal will guide participants through examples and a hands-on crisis simulation to show how Receive, Accept, Pause, Investigate, Decide, and Own can strengthen safety, consistency, and operational response.

**Transitioning to EV in Paratransit Operations (adding chargers and EV vehicles to diversify the fleet) – RM: 108/109**

**Description:** Sun Metro’s current paratransit fleet utilizes vehicles powered by Compressed Natural Gas (CNG). As part of our commitment to building a more robust and resilient fleet, Sun Metro plans to replace 45 vehicles with Paratransit Battery Electric Vehicles (BEVs). This initiative is designed to improve the quality of life for our customers while advancing our commitment to reducing carbon emissions and promoting environmental justice in the communities we serve. By transitioning to electric vehicles, Sun Metro continues to provide safe, dependable, and timely public transportation while moving toward a more sustainable future. To guide this transition, we evaluated several key areas, including: project concept, scope, financial considerations, electric vehicles, infrastructure, training, operational challenges, project launch, and lessons learned. This presentation will highlight both the challenges and pitfalls encountered during the process, as well as the successes and best practices that helped make this initiative successful.

**Investing in Roadway Safety is Imperative – Doubling Down on What Works – RM: 101**

**Description:** Texas roads are deadly: in 2024 alone, there were 4,150 traffic fatalities (TxDOT). But employers have a powerful tool to change that—by influencing the driving behaviors of their workforce. With over 60% of Texans employed, organizations have a "captive audience" to promote safe driving, prevent crashes, and reduce costs. The good news? Roughly 90% of crashes involve human error, meaning targeted driver safety programs can make a real difference. By leveraging proven countermeasures and best practices, employers can transform their transportation safety programs into powerful drivers of behavior change. This session will provide practical strategies for making roadway safety a core part of your organizational culture. Attendees will walk away with actionable tools to reduce risk, address liability, and implement effective safety initiatives that protect employees behind the wheel. **Prepare for Kickoff: Moving the Masses with Event-Based Transit – RM: 104/105**

**Description:** As Texas continues to host major events—from the World Cup to the State Fair of Texas and the Texas–Oklahoma football game—transit access on game day is becoming increasingly important. Big events bring large crowds, and with the right strategy, transit agencies can move people efficiently while boosting ridership and visibility. Beyond transporting attendees, agencies can also generate revenue through on-vehicle and station advertising, digital promotions, and partnerships that include co-branded marketing and discounted tickets. This session highlights practical insights from agencies already managing large event transportation, including how CitiBus supports Texas Tech football games, how Minnesota Valley Transit Authority prepares for professional sports events, and how DART and Trinity Metro are planning to move millions during the World Cup. Attendees will learn how event-based transit can increase ridership, create new revenue opportunities, and expand community engagement through effective planning and partnerships.

**Microtransit: Planning and Implementation Lessons and Practical Tools - RM: 108/109**

Wednesday: 11:05-11:50 am (45 Min)

**Description:** Microtransit continues to gain attention as transit agencies explore new ways to improve mobility beyond traditional bus service by providing flexible point-to-point transit and/or first- and last-mile service to fixed-route transit. This interactive session will highlight best practices for planning, implementing, and operating microtransit across the country in a variety of contexts including rural, suburban, and urban areas. Presenters will share research insights and discuss challenges in planning for and managing an effective on-demand microtransit service. The session will include two hands on exercises that address two scenarios: 1) agencies considering implementing microtransit service, where facilitators will guide attendees through the process of deciding where microtransit should operate within a service area as well as the service design (e.g., point to point, point to fixed route); and 2) agencies currently operating microtransit service that will focus on best practices and considerations for setting service standards and the process for adjusting service based on performance. Attendees will gain real-world lessons, best practices, and tools to evaluate whether microtransit could work in their areas as well as evaluate the effectiveness of existing services.

**Understanding How FTA's Funding Formulas Really Work— RM: 111/112**

**Description:** FTA's Funding Formulas depend on a mix of data from the National Transit Database and the decennial Census. But what data elements are actually most important to determining how much formula funding goes where? Also, some of the formula factors date back to the 1980s. The nation has changed a lot since 1980. How has that impacted how the formulas work? Attend this session and learn how FTA calculates those formula apportionments, and how the NTD data your system reports contribute to deciding formula allocations.

**Citizen Response to Active Shooter Events (CRASE) - RM: 101**

Wednesday: 1:30 -2:30 pm (60 Min)

**Description:** The objective of this course is to enhance the survivability of individuals involved in an active shooter incident. Students will be given strategies that are simple to recall and execute under conditions of extreme stress.

This course introduces a structured response model—Avoid, Deny, Defend—designed for civilian application within their communities. After taking this class participants will be able to disseminate this information upon returning to their respective communities. By adopting this model, civilians can improve their ability to retain critical information and respond effectively under stress, thereby increasing the likelihood of saving lives and reducing casualties during active shooter events.

**Managing Operational and Capital Costs at Rural and Small Urban Transit Systems – RM: 104/105**

**Description:** As costs continue to rise, Texas rural and small urban transit agencies need practical tools to better manage both operational and capital expenses. This workshop condenses 2.5 days of training developed by TTI with support from TxDOT into a focused session covering key cost management strategies. Participants will receive an overview of the free Managing Costs guidebook and online course, learn foundational concepts such as transit cost drivers and cost analysis, and explore practical approaches to managing labor, fuel, vehicle maintenance, and replacement costs.

**Growing Your Own Workforce: Inside VIA’s Fleet Maintenance Training Program – RM: 108/109**

**Description:** VIA's fleet maintenance training program follows a curriculum designed to take non-technical employees through a series of training modules that provide classroom, instructor-led training with experiential in-shop assignments. The program includes defined learning objectives and evaluation criteria that must be met. Employees who successfully complete the program are hired into open fleet mechanic positions within the fleet maintenance division. The presentation will provide a detailed overview of VIA's program, highlighting success stories and discussing challenges encountered during implementation. Attendees of the presentation will receive editable e-copies of VIA's curriculum, syllabuses for all training modules, and samples of written exams and hands-on evaluations. Maintenance managers and training staff who would like to create or enhance an in-house training program that will provide opportunities for non-technical personnel to move into technical positions would benefit from this presentation.

The session will also explain how traditional guaranteed-cost insurance differs from collaborative risk-sharing approaches used in cooperative transit insurance programs.

**Attracting and Retaining Talented Workers Throughout the Employee Life Cycle – RM: 108/109**

**Description:** Many transit agencies across Texas and the U.S. are understaffed and struggling to attract and retain great frontline employees. How do we get the best possible candidates in the door and support their success in the industry? In this presentation, Shayna Gleason of the Transit Workforce Center, FTA's national technical assistance center for workforce development, will share innovative recruitment and retention initiatives gathered from local-level experience and national-level research, highlighting a range of potential solutions for agencies of all sizes. First, Gleason will discuss innovative messaging and recruitment strategies used in various transit settings to convey the benefits of working in public transportation and how agencies have used partnerships to recruit from untapped employee populations. Next, she will introduce best practices from recent research on methods for streamlining bus operator hiring practices, as well as information on how agencies are experimenting with work schedules to improve employees' work-life balance, reduce absenteeism, and promote retention. Third, Texas-based transit presenters will speak about structured mentoring programs and the benefits of mentorship for morale and retention among frontline employees. ### **Doing More with Less: Cost Savings through Productivity, Communication, and Service Design – RM: 107**

**Description:** Rural transit agencies are often facing a reality of decreased funding mechanisms for public transit. This session is designed to give rural and small urban transit agencies strategies to ensure excellent transit service delivery without breaking the budget. Strategies discussed will include proper service design and productivity, stakeholder and public engagement, and communication and marketing efforts that can help transit agencies transport more people using fewer service hours or dollars.
