#### Speaker Information for Monday, June 22 (in order of appearance)



#### Hon. Jimmie V. Reyna, United States Court of Appeals for the Federal Circuit

Jimmie V. Reyna is a Circuit Judge on the United States Court of Appeals for the Federal Circuit. Prior to his appointment, Judge Reyna practiced international trade and customs law and policy in Washington, D.C. for over 25 years with Stewart and Stewart (1986-1998), and Williams Mullen (1998-2011) where he directed its International Trade and Customs Practice Group and served on its board of directors. Judge Reyna served on the U.S. roster of dispute settlement panelists for trade disputes under NAFTA Chapter 19, and the World Trade Organization Dispute Settlement Mechanism (1995-2011). Judge Reyna is the author of two books and numerous articles on trade and customs issues, and was the founder and Senior Co-Editor of Hispanic National Bar

Association Journal of Law and Policy. Judge Reyna is a recipient of numerous awards for service to the legal profession, served as National President for the Hispanic National Bar Association and in various leadership positions in the ABA. He received a B.A. from the University of Rochester, and a J.D. from the University of New Mexico School of Law.



#### Bart Newland, Vice President and Chief IP Counsel - Biogen Idec

Bart Newland is Vice President and Chief I.P. Counsel of Biogen Idec, the world's oldest independent biotechnology company. Biogen Idec uses cutting edge science to discover, develop, manufacture and market products for the treatment of serious diseases with significant unmet medical needs including multiple sclerosis, Alzheimer's disease, ALS, Parkinson's disease and hemophilia. Biogen's commercial products and r&d pipeline include both biologics and drugs. From 2001 through 2009, Bart served as Vice President for Intellectual Property at Genzyme Corporation, where he built and managed teams responsible for ip related to recombinant protein therapeutics, gene therapy,

small molecule drugs and biomaterials. He managed Genzyme's ANDA patent litigations involving multiple defendants in multiple jurisdictions. Prior to joining Genzyme, Bart was a partner at Rothwell, Figg, Ernst & Manbeck in Washington, D.C. Bart's practice at Rothwell, Figg encompassed all phases of patent law and included a substantial amount of patent litigation for both research-based pharmaceutical and biotechnology clients as well as generic drug companies.



#### Ralph Schroeder, CEO, Helios Intellectual Property

Ralph Schroeder is CEO of Helios Intellectual Property, a managed services firm that specializes in IP operations management. Helios works with corporate IP groups on process improvement, organization design and software systems. Ralph has worked for a number of well-known IP service companies including Hyperion, Anaqua, Dennemeyer and PwC. Ralph started his professional career in IP as an attorney specializing in litigation, regulatory compliance, and transactions.



#### Brian Stierwalt, Chief Intellectual Property Counsel, ConocoPhillips

Brian is currently the Chief Intellectual Property Counsel for ConocoPhillips, and he is located in Houston Texas. Brian has practiced as in house counsel for over 25 years. #### Karen Borrelli, Chief Patent Counsel, Newell Rubbermaid

Karen Borrelli is Chief Patent Counsel at Newell Rubbermaid, Inc. She is responsible for the patent prosecution and litigation strategies for brands such as Graco, Calphalon, Waterman, Sharpie, Levolor, Rubbermaid, and Irwin Tools. Karen joined Newell Rubbermaid in 2007 and has been Chief Patent Counsel since 2011. Ms. Borrelli has a background in domestic and international patent prosecution and litigation in the mechanical arts. She began her law career in 1999 as a summer intern for the United States Court of

Appeals for the Federal Circuit in Washington, DC and also worked as an associate for the DC office of the law firms McKenna Long & Aldridge and the firm now known as K&L Gates. Prior to joining Newell Rubbermaid, she was Senior Patent Attorney for Ciba Vision, a Novartis Pharmaceuticals Company, in Atlanta. Ms. Borrelli received a Bachelor of Mechanical Engineering degree in 1998 from the Georgia Institute of Technology and her law degree from the Catholic University of America in Washington DC in 2001. She is licensed to practice in both Georgia and Washington, DC, as well as before the United States Patent and Trademark Office.



#### Dana Colarulli, Director, Office of Governmental Affairs, USPTO

Dana Colarulli is currently the Director of the Office of Governmental Affairs and a member of the Executive Management team at U.S. Patent and Trademark Office, which he joined in December 2009. He has two decades of experience working in and with the Federal government and the U.S. Congress in various roles. Though these various positions, Mr. Colarulli has facilitated discussions addressing a wide range of substantive and operational issues related to intellectual property law and policy and to the U.S. government. While in his current position, Mr. Colarulli facilitated discussions within the agency and on Capitol Hill related to a variety of reforms of the patent and trademark systems including enactment and effective implementation of the *Leahy-Smith American Invents Act* (Public Law 112-29), international treaties and on recent proposals to address abusive patent litigation. He has also

coordinated USPTO personnel and resources to support operations at USPTO and its annual budget requests, authority to access fee collections and increase USPTO's spending authority. Before serving at the USPTO, Mr. Colarulli was the Director of Government Relations for the Intellectual Property Owners Association (IPO) for seven years Prior to this position, Mr. Colarulli served on Capitol Hill as a law clerk for Senator Maria Cantwell from Washington State addressing technology and IP issues in front of the Senate Judiciary Committee. Mr. Colarulli also worked at the Washington, DC law firm of Verner, Liipfert, Bernhard McPherson & Hand (now a part of DLA Piper Rudnick) in the Federal Affairs and Legislative Practice Group where his clients included small Internet start-ups, associations and large corporations with intellectual property and Internet related interests. Prior to this position, he served in the Federal government for five years in the U.S. Small Business Administration's Office of Entrepreneurial Development and at the U.S. Department of Health and Human Services, Administration for Children and Families in various positions. #### Sarah Harris, General Counsel, USPTO

As USPTO's General Counsel, Sarah Harris is the principal legal advisor to the Under Secretary of Commerce for Intellectual Property and Director of the USPTO. She supervises the provision of legal advice and court representation on intellectual property and administrative matters for the Agency. Ms. Harris is responsible for providing legal advice on patent, trademark, and copyright matters as well as administrative issues such as government contracts, personnel, and budgetary matters. As necessary, she coordinates with the Department of Justice, Department of Commerce, and other agencies in developing the U.S. position on major intellectual

property cases before the Supreme Court and Courts of Appeals. Prior to joining the USPTO, Ms. Harris served as Senior Vice President and Deputy General Counsel, Intellectual Property at AOL, Inc. and Associate General Counsel, Intellectual Property at Cooper Industries, Ltd where she established and managed the implementation of global corporate strategies for capturing, protecting, and exploiting intellectual property to complement corporate initiatives. Prior to AOL, she held IP positions with Hewlett-Packard, and Compaq, and served as Of Counsel at Haynes and Boone, LLP. Ms. Harris was the President of the Houston Intellectual Property Law Association and on the Executive Committee of the Association of Corporate Patent Counsel. She received her B.S. in Electrical Engineering from Texas A&M University and her J.D. from the University of Houston Law Center.



# Dan Hunter, Director, International Work Sharing, Planning and Implementation, Office of International Patent Cooperation, USPTO

Daniel Hunter graduated from Penn State in 1982 with a Bachelors of Science in Engineering Science. Following graduation, he was commissioned in the US Navy and taught at the Naval Nuclear Power School. Following a tour on the aircraft carrier USS America, he attended graduate school at the Naval Postgraduate School and received his Masters of Science in Electrical Engineering (Space Systems Engineering) in 1990. 
