Terms of Membership

Membership Eligibility

Partner Members are regional and/or statewide infrastructure organizations that do not have a grantmaking function but do have significant interaction with the nonprofit and philanthropic sectors.

This may include:

- Community action agencies
- Community Development Financial Institutions (CDFIs)
- Regional planning commissions
- Governmental agencies
- Chambers of commerce
- Community partnerships
- Regional and statewide associations
- Academic institutions/research institutions and think tanks
- Other infrastructure organizations

Final invitation to join as a Partner Member is made by the Philanthropy Missouri Engagement Committee and is based on the applicant's fit with the eligibility criteria stated above. Philanthropy Missouri does not discriminate on the basis of race, color, religion, national origin, sex, gender identity, sexual orientation, age, disability, or any other legally protected characteristics.

Conditions of Membership

In being considered for membership, an organization must indicate willingness to:

- Complete the Request to Join Form;
- State how your organization 1) aligns with PhilMO mission, vision, and values and 2) will expand the knowledge and capabilities of Missouri grantmakers and strengthen the philanthropic sector;
- Agree not to use membership to solicit* donations or business;
- Commit to equal opportunity practices in hiring; and
- Pay the annual membership dues when invoiced (following invitation to join and annually by January 31 thereafter).

**Solicitation includes but is not limited to use of the Member Directory and contacts to promote and/or make a direct ask for business or funding, and/or engaging in those types of activities in person during Philanthropy Missouri events and programs. Note that if Members feel solicitation has occurred, we reserve the right to revoke membership with no refund of membership dues.*
