Ultimately, the City of Spokane, as a Corporation, is my client and all recommendations or legal advice is proffered with this in mind. As City Attorney I viewed myself the head litigation attorney and therefore was involved in several litigation cases that I argued on behalf of the City.

City of Spokane v. State of Washington, Washington Department of Transportation, et al., 23-2-01083-32

City of Spokane v. State of Washington, Washington Department of Transportation, et al., was an action to declare the WSDOT homeless encampment a chronic nuisance. The encampment was having a dramatic and profound negative affect on the surrounding neighborhood. My office secured over 50 declarations of negative impacts on businesses and families in the area. I argued the matter in Spokane Superior Court and secured the designation as a chronic nuisance with an order to close the encampment. The encampment was closed within 60 days though it had been operating for 12 months prior to the filing of our case. I was able to give the neighborhood the relief they sought from the constant theft, vandalism and rampant drug use.- Spokane Superior Court, Judge Marla Polin

Spokane for Safe Neighborhoods v. City of Spokane, 22-2-03035-32

I represented the City in *Spokane for Safe Neighborhoods v. City of Spokane* arguing to quash a temporary restraining order against the City for the establishment of a long-term treatment shelter by Catholic Charities- the Catalyst Project. I represented the City's interests and fought to absolve the City of any risk and liability. I was successful in having the City of Spokane dismissed from the matter completely.- Spokane Superior Court, Judge Annette Plese

I have handled several cases in my career that were a turning point in the life of a victim of domestic violence. On occasion, it is possible for a victim of domestic violence to find the strength to face their batterer in court and tell their story. This results in a change in the dynamics of the relationship and allows the victim to stop further abuse at the hands of the batterer. Sometimes this occurs outside of the criminal justice system but I have enabled victims to achieve this through the support of the YWCA advocates along with multiple meetings with the victim, showing the support of the City Prosecutor's Office and law enforcement agencies. I cannot give a number of these occurrences but it is a large part of my day-to-day endeavors, fostering this event and is a significant achievement every time it occurs.

City v. Cook, 4Z0832772

The defendant had assaulted the victim on many occasions along with her sister. The defendant had terrorized the entire family. I traveled to their home and met with them several times. By building a relationship with the family, the victim was willing and able to testify against the defendant. When he learned this, he took a plea to avoid trial. More importantly, the victim had gained the confidence to sever ties with the defendant and left the relationship.

City v. Jackson, P10000128

The defendant exposed himself to several young ladies on the campus of Spokane Community College. One victim in particular was extremely nervous about testifying and was afraid of retribution. I worked with her in the weeks leading up to the trial, she was able to tell her story and felt empowered instead of victimized. She realized a strength she did not know she possessed.

City v. Hocking, multiple files.

Mr. Hocking was arrested several times for obstructing and other minor charges. He was a homeless person and was addicted to drugs. Every time he came to court he would represent himself and often, he was incarcerated. He motioned the court for access to the law library, I took a copy of the court rules to the jail so he could use them in his pleadings. He was grateful that the prosecutor was aiding in his defense. Mr. Hocking filed many motions and argued them to the court. My actions helped him protect his rights under the law. Mr. Hocking was able to recover from his addiction and is a contributing member to our community. Mr. Hocking and I are friends to this day.

While in the City Attorney's office I have handled several land use matters before the Spokane City Hearing examiner. Several were appealed to Superior Court where I represented the City in the LUPA appeal process.

Please briefly describe any legal non-litigation experience that you feel enhances your qualifications to serve as a judge.

As City Attorney I was in charge of an office that advised over 30 departments. The Mayor and City Council were my direct clients and I helped them navigate municipal matters. I supervised 23 lawyers and 11 support staff. Along with policy recommendations to City departments, the City Attorney's Office reviews all contracts the City enters. I was personally involved

in several Contracts negotiated by my office or the department on behalf of the City, then reviewed by myself. I was involved in collective bargaining negotiations with the Spokane Police Guild, and Spokane Association of Fire Officials.

As referenced in my community and civic activities section, I have coached soccer for over 20 years. Through this process I am required to evaluate players and implement plans and strategies in order to help players develop and succeed. If a player is not having success in a certain area, it is my responsibility to change the focus of practices and develop practices that will develop the lacking skill-set. I am continually evaluating players and my team to determine our weaknesses. This is not unlike the responsibility of a judge to evaluate how to rehabilitate a criminal defendant through treatment. By evaluating the information gleaned from counsel, the Judge is required to determine the best course of action to help rehabilitate the defendant and provide for community safety.

In addition, I have negotiated contracts between my union and City of Spokane on 3 or 4 occasions. I also negotiated a contract for services with the YWCA in or about 2008.

For over 20 years, I have coached youth soccer as a volunteer. I have coached ages from four years old to eighteen years of age. I have experience playing college soccer and I have made an effort to pass along the knowledge and skill I developed, to future generations of soccer players. I have continually pursued coaching licenses to improve my ability as a coach. I have passed the D, C and B coaching license programs through the Unites States Soccer Federation. I spend between 200 and 300 hours a year coaching multiple teams. I have affected many young lives and some examples of the impact I have had are that: I have been invited to multiple high school graduations, I have been listed as a reference on multiple college applications, I have been asked to speak with college coaches on behalf of players, and one player thanked myself and my assistant coach for keeping him out of legal trouble by giving him a structured environment that he did not have elsewhere in his life. I am proud of my devotion to the sport and the impact I have had on hundreds of young lives.

X. Access to Justice and Diversity in the Legal Profession

Please describe any activities that you have engaged in to eliminate bias or improve access to the judicial system.

For a majority of my career, I helped women have a voice in court. Early on it was representing clients in employment law matters. Our clients were overwhelmingly women who were discriminated against in the workplace. I was mentored by a terrific attorney, Christine Weaver, and we worked hard to secure compensation for our clients.

While employed by the City Prosecutor's office, I worked on behalf of victims of domestic violence and their children. The population is overwhelmingly female. I interviewed, counseled, and empathized with victims, all the while, seeking justice for them in court.

What are the most significant barriers to access to justice today? In what ways have you seen these barriers in your practice?

One of the most significant barriers to access to justice today is the lack of understanding of the legal system. The legal system, with its multiple courts, is extremely complex. It is difficult for people to understand and navigate the system. This can be compounded if a person is a non-english speaker or is uneducated. In my practice, I have helped victims of domestic violence and victims of adverse employment actions navigate the legal system. I have made myself available to explain the process and provide them with a better understanding of the system.

As a member of the bench, what role, if any, do you believe that a judge has to enhance equal access to justice?

As a judge, it is important to give all parties related to a matter, the opportunity to be heard. This can be done by providing sufficient time for hearings to take place and to allow parties to present their information to the court. It is also very important to be prepared for motions and hearings by reviewing the matters before court so that the judge has a good grasp on the arguments made by both sides.

What experiences, training, or knowledge do you have in addressing diversity in the legal profession?

I have had little opportunity to address diversity in the legal field. Through youth soccer, I have had significant contact with immigrant populations. I have coached many players that immigrated to the United States, I have encouraged them and made them feel valued in our program.

What can a judge, or court, do to improve diversity in the legal profession?

As a member of the bench, a judge can help foster diversity by speaking to diverse groups. All level of individuals should be targeted including school aged children up to graduate level students. By explaining the process in how to achieve a career in the law, I feel it would help those in minority groups have an understanding of the process and give them the drive to pursue a career in the law.
