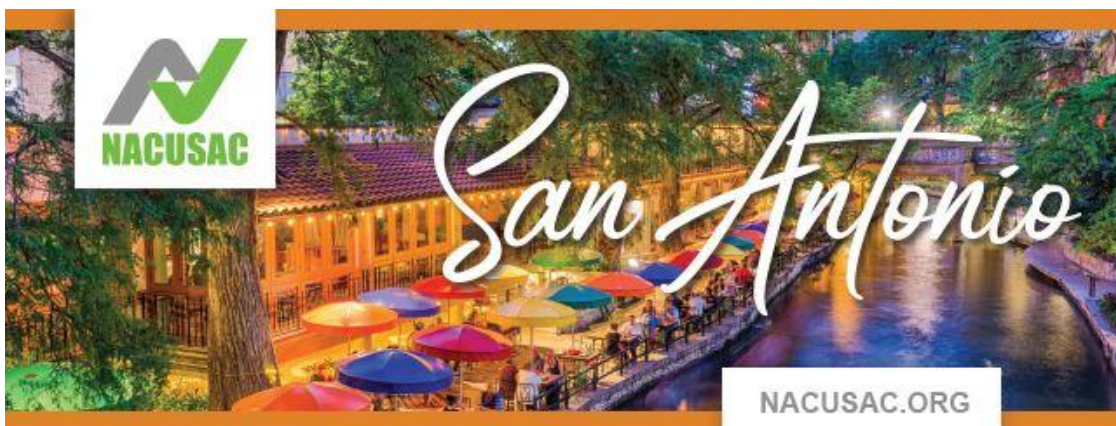

NACUSAC Board of Directors is Seeking Candidates!

NACUSAC is currently accepting nominations for the Board of Directors. In June, three board terms will be up for election. Incumbents Mike Kucera (Eglin Federal CU), Mike MacFeeters (CU of New Jersey) and Bill Stauder (Vacationland FCU) are seeking re-election for three-year terms.

To qualify for nomination, you must serve as a current supervisory/audit committee member of a credit union that is a member in good standing with NACUSAC. You must also enroll in or be a graduate of NACUSAC University. Along with your nomination please submit a letter of support from your credit union Board Chair or CEO.

The nomination deadline is Friday, March 15.

The NACUSAC Board holds one to two in-person meetings annually as well as virtual meetings on a quarterly basis. The Board plays a vital role in the development of NACUSAC's educational and training programs, membership initiatives and input into conference programming.
