
Greetings to hunger relief partners across the State,

WSDA Food Assistance (FA) writes this update knowing that it is reaching you in a time of great uncertainty, as the demand for services continues to grow and the predictability of food and funding resources is low. FA is increasing its efforts to provide you with the most real-time information available, with the understanding that it can change almost on a daily basis. We hope this article helps clarify what is known, our approach to supporting and communicating with you, and what updates you can expect moving forward.

We want to start with some good news! We are pleased to announce that the application window is now open for WSDA FA Resiliency Grants for the upcoming state fiscal year (July 1, 2025-June 30, 2026). The application is open for 45 days and closes at 11:59 pm PDT on May 22, 2025. We encourage you to visit the Resiliency Grants webpage for grant details including funding priorities, FAQ's, an application guide, and rubric. WSDA FA Resiliency Grant Application Office Hours with FA Resiliency Grants staff are being held from 1:30-2:00 pm on April 18th, May 2nd, and May 16th.

WSDA FA heard loud and clear, given the current uncertainty, the requests for more frequent communication about program and funding updates. To support that effort, WSDA FA has begun using the "What's New?" section of our Food Access webpage to provide the latest program updates. "What's New?" allows FA to provide (publicly) accessible updates to partners and stakeholders. FA will continue to provide direct updates at our General and Lead Agency Check-in Meetings, but encourages you and those in your network to utilize the "What's New?" resource for more frequent updates. At the time of writing this article we have detailed information posted about programs such as LFPA, LFPA Plus, LFPA 25, and TEFAP CCC.

We did want to highlight some updates in LFPA as well. First, we have published an LFPA Program Impact (2022-2024) Infographic (pictured right). We have also posted information on the "What's New?" section named above that provides a recap & update on LFPA, LFPA Plus, and the recently cancelled LFPA 25. Since that update, USDA has granted a No Cost Extension giving many LFPA and LFPA Plus Lead Agencies additional time to utilize those funds through 12/31/25, rather than the previous funding period end date of 6/30/25. This will support WA's emergency food providers and farmers, giving them another growing season to utilize these dynamic funds.



In other funding updates, we wanted to share this message below from WSDA Agency Leadership on the status of state funding for the new biennium (July 1, 2025 – June 30, 2027).

The Washington State legislative session is well underway, and the Legislature is currently working to reconcile the House and Senate's proposed budgets. The operating budget that they adopt for Governor Ferguson to sign includes the supplemental budget for the current year, which does not affect WSDA's Food Assistance programs, as well as the 2025-2027 biennial budget, which begins in July 2025 and ends in June 2027. The available funding levels for state-appropriated Food Assistance programs at WSDA are uncertain until that budget is adopted and signed by the Governor, which is anticipated in May. WSDA recognizes that communities across the state are impacted by the uncertainty of this critical operating funding, and the difficulty that the legislative timeline puts on organizations' planning; we will continue to provide updates as they are available.

On the federal funding front, there are some pieces known and some still unknown. The CSFP (Commodity Supplemental Food Program) budget for FFY25 has seen a reduction in caseload and funding nationwide. This reduction has resulted in a caseload (seniors) loss of 91 and a reduction in federal funding in Washington as well. We are committing state funds to support our CSFP Lead Agencies, making them "whole" and deeply appreciate their efforts in serving at or above their caseload prior to that reduction in an effort to support a potential increase in caseload had it been available.

TEFAP budgets are not yet clear for the current 2025 Federal Fiscal Year and FA continues to monitor the projected volume of food coming to the State through various TEFAP sources such as TEFAP Entitlement, TEFAP Bonus, and TEFAP CCC. Recently there was a substantial cancellation of TEFAP CCC orders that had been placed, however USDA has not officially communicated that the program has been terminated. At the same time, we have been able to place quite a few orders through TEFAP Bonus channels in recent weeks. We continue to monitor TEFAP food volumes, and work diligently to identify additional foundational foods we can bring in to support food pantries and meal programs in Washington State.

We continue to be appreciative of your partnership, continued engagement, and above all – your commitment to providing reliable offerings to communities across the state. We find the stories and impacts you share with our staff invaluable and center this information in our policy and funding discussions.
