WSDA NEWS



WSDA Food Assistance (FA) team is overflowing with things to celebrate these days!

First, we want to highlight the immense gratitude we have for the work you all are doing day in and day out.

Hunger relief organizations in Washington continue to be reliable, consistent, and positive service providers in the lives of many people across the state. You've continued to show up for the communities you serve, and while the volume of service being provided has once again increased in the last year, we know that one reason for that is your commitment across the state to providing high quality services that meet the most critical needs of people seeking your assistance. We cannot emphasize enough the appreciation The we have for this network of hunger relief partners who continue to improve and inform our work in WSDA Food Assistance.

FA staff have been excited to hit the road and connect with so many partners in person recently! Staff have been conducting program compliance reviews in the last couple months, visiting sites including Tribes, Lead Agencies, and Sub Agencies to better understand the work they're doing and provide technical assistance to ensure that things are running smoothly both for the organization's staff and volunteers, and the people they serve.

During this review season, the team has noticed impacts of the infrastructure investments in recent years that are coming to fruition. This includes expanded cold & frozen storage, and vans & trucks which allow sites to access donations of foods they were previously unable to receive. The more often sites have been able to say "yes" to those donations, the more regularly they are being contacted for additional opportunities.

Another theme across the state was the incredible partnerships that have developed between hunger relief organizations and their local food producers through opportunities like the USDA Local Food Purchase Assistance (LFPA) program. Food Pantry staff and volunteers take pride in that food being distributed, and some sites have gone even farther to ensure clients feel connected to the source of their food by having a note on display identifying the source, which might be the farm down the road people drove by to get to their food bank.

The recent Washington Food Coalition Conference was another opportunity for FA staff to get face time with folks; including the chance to interact directly as a team as many of us work remotely, learning from our partners, and building relationships with the 275 conference stakeholders who attended. On top of the networking opportunities, FA staff were able to share a bit about the work we do within WA's hunger relief system. We hope those of you who went enjoyed it as much as we did!

Following the conference, we had the chance to share highlights with other staff at WSDA through our Division Newsletter. We take pride in getting to highlight the work you do and keeping other staff in the agency informed of the latest happenings in the world of hunger relief. In that newsletter, we highlighted the incredible project that Chelan Douglas Community Action Council (CDCAC) is undertaking to create a "new home" for CDCAC and provide a much-needed upgrade to the emergency food distribution system in their service area. Many people at the conference had





the chance to tour the new facility alongside a few members of our team!

Boasting massive cold and frozen storage, the new facility allows CDCAC to take large donations of fresh and frozen items they previously would have been unable to take. The dry storage is also a much-needed improvement and has room to store three times the amount of food, all while housing program equipment & vehicles and the CDCAC weatherization program as well.

CDCAC has created a new food pantry in the building as well, providing Wenatchee residents seeking food assistance with a wonderful and inviting space to access food!

Amidst the exciting work named above, we are in the process of closing out Federal Fiscal Year 2024 (FFY 2024) which means that our regional representatives and business operations team will be heavily engaged in one-on-one discussions with hunger-relief organizations to ensure a full spend-down of all federal funding ending September 30, 2024. At the same time, we will be issuing new federal agreements for FFY 2025, updating procedures manuals, state plans, and forms. In addition, we were just notified that we will be receiving another audit from the State Auditor's Office for two of our federal programs.

Washington Food Coalition Conference Sept 18th -20th, 2024 • Wenatchee Conference Center

That's a wrap - 2024 WFC's annual conference in Wenatchee was one for the record books! 280 registrants and a record number of exhibitors, made it our largest event yet. This achievement wouldn't have been possible without our generous sponsors and dedicated planning committee.

This was my second time attending and my first year as the conference Committee Chair. WFC's Trish Twomey and our committee met twice a month via Zoom starting in spring with delegated projects between. Living in NE WA, one of the biggest challenges in helping to organize the event in Wenatchee, was selecting venues/vendors sight unseen researching hotels, reception and dinner locations, caterers, speakers, etc. However, watching the conference come to life, was so rewarding!

Thursday started with a group breakfast; I had the privilege of introducing author Stephanie Land, whom I hoped would be our keynote speaker since day one. She shared her story of navigating poverty and long-lasting trauma caused by hunger. Her insights were a powerful start to the day.


